

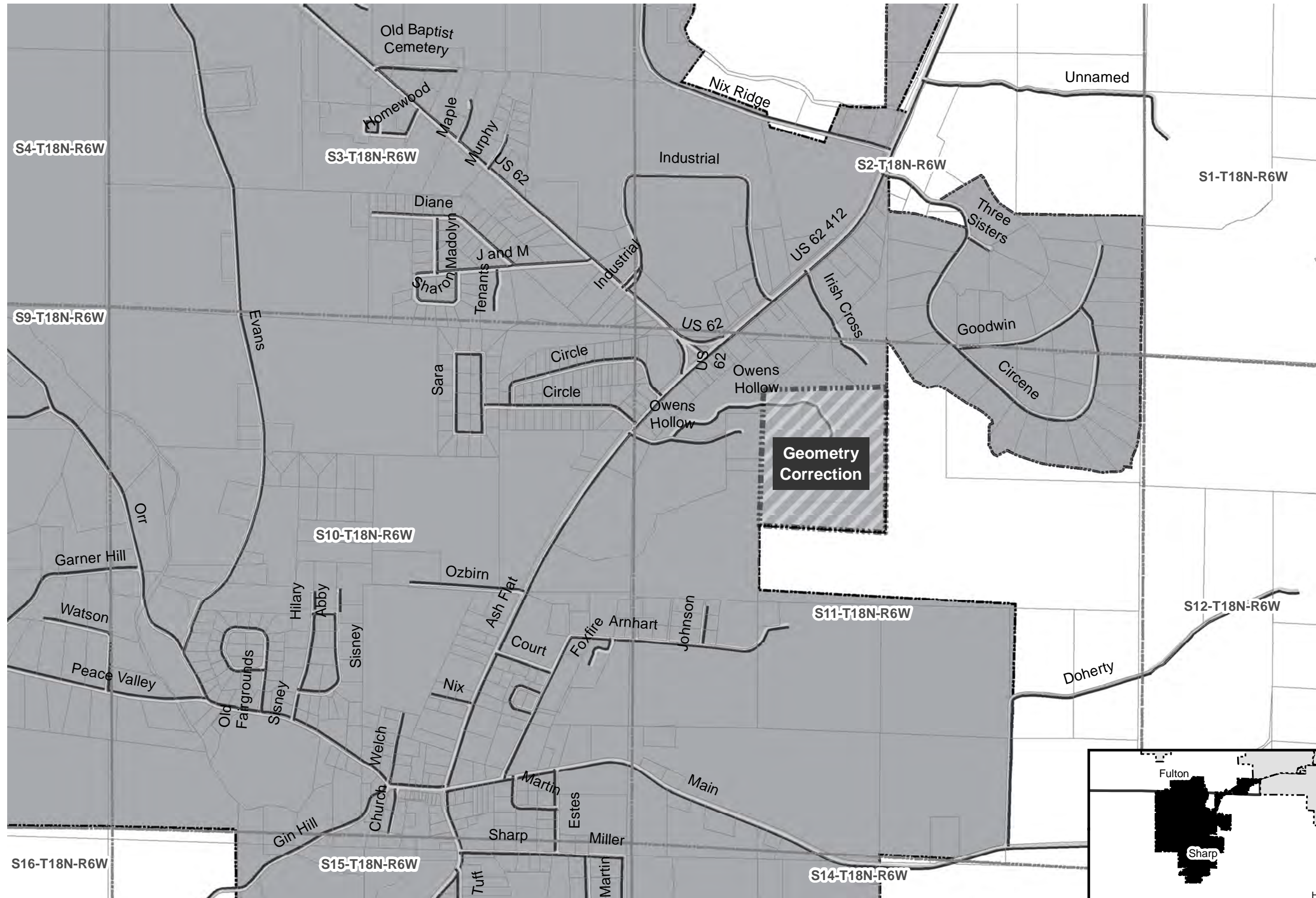

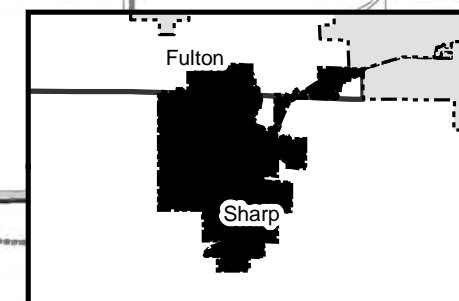
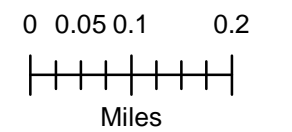
Arkansas Code 14-40-101.

ORDINANCE APPROVING ANNEXATION

WHEREAS, there has been presented to the Town Council of the Town of Ash Flat an Order of Annexation duly executed by the County Judge of Sharp County authorizing the Annexation of certain territory to the Town of Ash Flat, it appearing that more than a majority of the inhabitants of the area being annexed signed a petition asking to be annexed into the Town of Ash Flat; that a plat as required by law was filed in the County Court of Sharp County and that the Mayor and City Council approves of said annexation; and

WHEREAS, said Town Council of the Town of Ash Flat finds that said Order of Annexation was done according to law and that it is in the best interest of the Town of Ash Flat that said area be accomplished into the Town of Ash Flat by the Town Council; NOW, THEREFORE

BE IT ORDAINED by the Town of Ash Flat by its Town Council:

That the area referred to in the Order of Annexation dated November 21, 1975, in the County Court of Sharp County be and the same is hereby approved and ratified and that the Mayor and Town Council accepts such annexed area and that a copy of this ordinance be filed in the case with the Clerk of the County Court as by law provided.

Enacted and ordained by the Town Council of the Town of Ash Flat, Arkansas, in special meeting assembled at the city hall in said Town this 25th day of November, 1975.

That the allegations in said petition are true and the requirements of Arkansas Statute Annotated 19-301 have been complied with and that the limit of the territory to be annexed were accurately described in the attached plat and that the prayer in the petition are right and proper and that said petition should be granted.

IT IS THEREFORE by the court considered, ordered and adjudged that the territory shown in the attached plat should be annexed into the Town of Ash Flat, Sharp County, Arkansas, and that a resolution of the Town Council of said town should be passed accepting the annexed territory.
