



ORDER OF ANNEXATION

On this November 21, 1989, comes to be heard the Petition of 48 property owners praying for the annexation of the following described land to the City of Jonesboro, Craighead County, Arkansas:

A part of Section 9, Township 14 North, Range 3 East, being more particularly described as follows: Begin at the Northwest Corner of Section 9, Township 14 North, Range 3 East; thence South on the Section Line to the Northwest Corner of the Southwest Quarter of the Northwest Quarter of said Section 9, the point of beginning proper; thence East on the 40 acre line to the centerline of the Saint Louis/San Francisco (Burlington/Northern) thence Southeasterly with meanderings with said railroad centerline to a point 300.00 feet North (measured at right angles) of the centerline of U.S. Highway No. 63-B; thence West parallel to and 300.00 feet from the centerline of U.S. Highway No. 63-B to the intersection with a line parallel to and 300.00 feet West (measured at right angles) from the centerline of U.S. Highway No. 63; thence Southeasterly parallel to and 300.00 feet from the centerline of U.S. Highway No. 63 to the South line of the North Half of the Southwest Quarter of said Section 9; thence West on the 40 acre line to the West line of said Section 9; thence North on the Section line to the Northwest Corner of the Southwest Quarter of the Northwest Quarter of said Section 9; the point of beginning proper, containing 149.4 acres, more or less, subject to all rights of way and easement of record.
