

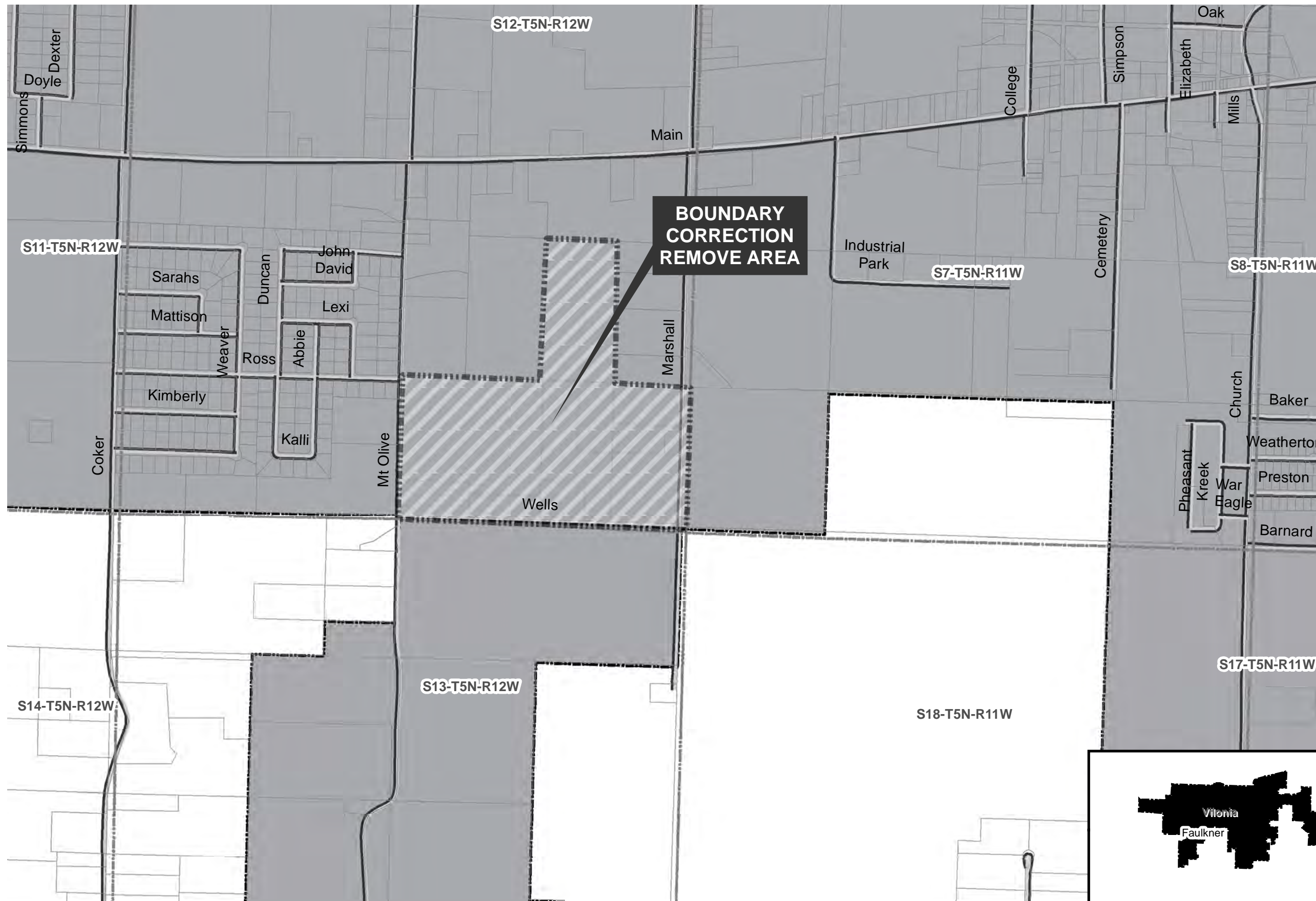

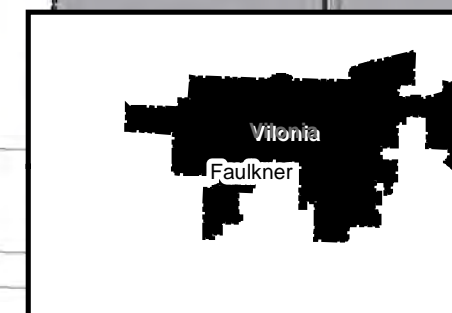
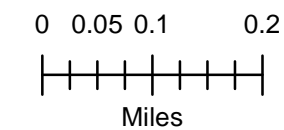

being described as follows:


