

ORDINANCE NO. 1995-1

TEB 2 7 1995

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TO STATEORY TO THE CITY OF OZARK, ARKANSAS, AND MAKENG SAME A PART OF. THE CITY OF OZARK, AND ASSIGNING SAME TO WARDS.

WHEREAS, petition was filed with the County Clerk of Franklin County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Ozark, Arkansas; and,

WHEREAS, on the <u>30th</u> day of <u>November</u>, 1994 the County Court of Franklin County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Ozark, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Ozark, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS:

SECTION 1: That the following described lands and territory contiguous and adjoining the City of Ozark, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Ozark, Arkansas.

That portion of land known as Lot 5 of Ozark Country Estates Phase 2, as was recorded in Plat Book "B" at page 80, in the Circuit Clerk's Office, Franklin County, Arkansas, and containing 5.87 acres, more or less.

SECTION 2: That the above described territory shall be annexed to and made a part of Ward ______ of the City of Ozark, Arkansas, and the same shall henceforth be a part of said ward as fully existing parts of said ward.





DECREE OF ANNEXATION

On this day of a regular term of the County Court of Franklin County, Arkansas, there is presented to the court by Billy D. Brockett and Debra Ann Brockett, the Petitioners, a petition for annexation of certain territory, hereinafter more particularly described, to the City of Ozark, Arkansas, and the Court being fully advised of the facts and the law, doth hereby find, judge and decree as follows:

The Court finds that the petition was filed more than thirty (30) days prior to this date and that in said petition the said Billy D. Brockett and Debra Ann Brockett were selected as Petitioners to act in the filing and presenting the petition.

The Court doth find that the majority of the total number of real estate owners in the area affected by this petition have signed said petition and that such majority owns more than one-half of the acreage affected.

The Court further finds that the territory sought to be annexed was accurately described in said petition and that said territory is contiguous to the boundaries of the City of Ozark, Arkansas.

The Court further finds that attached to and made a part of said petition is an accurate map of the territory sought to be annexed to the City of Ozark, Arkansas.

The Court further finds that the prayer of the petitioners is right and proper.

Therefore, the Court doth hereby ORDER, JUDGE and DECREE that the following described territory be and the same is hereby annexed to and made a part of the City of Ozark, Arkansas, to-wit:

That portion of land known as Lot 51 of Ozark Country Estates Phase 2, as was recorded in Plat Book "B" at page 80, in the Circuit Clerk's Office, Franklin County, Arkansas, and containing 5.87 acres, more or less.

The Court doth further order that the original papers in this cause be delivered to the Clerk of Franklin County, Arkansas, same to be properly recorded upon the records of Franklin County, Arkansas, and in the Clerk, after properly recording and filing the original papers, prepare transcripts of same; that one of the certified transcripts be delivered to the City of Ozark, Arkansas, one copy to the Secretary of State and one copy to the Director of the Tax Division of the Arkansas Public Service Commission.
