AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF FLIPPIN, ARKANSAS, AND TO ANNEX PROPERTY TO THE CITY OF FLIPPIN, ARKANSAS AS Individed.

WHEREAS, a petition was filed with the County Clerk of Marion County, Arkansas, by the real estate owners of the land hereinafter described, praying that said lands be annexed to and made a part of the City of Flippin, Arkansas; and

WHEREAS, on the by day of October 1997, the County Court of Marion County, Arkansas, found that said petition was signed by all of the fee simple owners of said property; that said territory, showing its relationship to the present city, has been filed and made a part of said annexation petition; that proper notice has been given for the time and in the manner prescribed by law; that said lands and territory should be annexed to the City of Flippin, Arkansas, subject to the acceptance of the same by the City Council of said City at the proper time as provided by law; and

WHEREAS, the time fixed by law for appealing from said Order of annexation made by the County Court has expired, and no appeal has been taken from said Order; and

WHEREAS, after due notice as required by law, the City Council of the City of Flippin, Arkansas, has heard all persons desiring to be heard and has ascertained that said petition was signed by all the owners of the real property in said territory; and


