Greetings;

We, the undersigned petitioners and qualified voters respectfully ask your honorable court to designate and incorporate the following described territory into an incorporated town to be known and named PERRY, ARKANSAS, to wit;

The south half of section twenty seven, and the northeast quarter of the northwest quarter and the northwest quarter

of section Thirty four all in Township Five North of Range seventeen west as shown by the following map the red of which indicate the territory to be included in the said incorporated town and lying in Perry county, Ark. Zas.

Now on this day comes on for hearing, the petition of legal and qualified voters of the incorporation of the town of Perry, and come the petitioners by B.E.Cragar, designater, and by leave of the court the petition is amended by excluding from the designated boundary all of the Northwest quarter of the Southwest quarter, in Section Twenty seven in Township Five North in Range Seventeen west, lying north of the rightofway of the Chicago Rock Island and Pacific Railroad; and the court now finds that the law has been in all things complied with in the filing of the petition and giwing notice and in all other respects.

That said petition is signed by more than twenty qualified voters residing in the territory hereinafter included in said incorporation that the limits are accurately described and an accurate map has been made and filed; the name of PERRY is proper and sufficient to distinguish it from other like places in the state and that it right and proper to grant said petition. It Is by the court considered ordered and adjudged, that the following territory be and is hereby incorporated and organized as an incorporated town under and by the name of the Incorporated Town of Perry, to wit; All of the south half of section twenty seven in Township Five North of Range seventeen west; except that part of the North west quarter of the southwest quarter lying north of the railroad rightof way, and also the northeast quarter of the northwest quarter, and the north west quarter of the northeast quarter, of section Thirty four in said Township and range. That said town so incorporated to have all the powres confered by law upon incorporated towns in the state of Arkansas,. Signed. W.A.Linebarger, County Judge.
