

TOWN OF BIRDSONG RESOLUTION NO. 1996-



WHEREAS, on the 6th day of December, 1995, J. M. Speck and SHARON PRIEST Earl Pettigrew filed a Petition in the County Court for Mississippi Formation County, Arkansas, Osceola District, in case number Co-95-67 petitioning the court for annexation of territory to the Town of Birdsong, Arkansas; and

WHEREAS, notice of the hearing on the petition for annexating on PRIEST SECRETARY OF STATE was duly published in the Osceola Times in the time and in the manner required by law on January 18, 1996 and January 25, 1996, and February 1, 1996; and

WHEREAS, on the 6th day of February, 1996, the County Judge for the County Court for the Osceola District of Mississippi County, Arkansas entered an Order of Annexation of the territory to the Town of Birdsong; and

WHEREAS, the Town of Birdsong, in accordance with Arkansas Code Annotated 14-40-605, desires to accept the annexed territory to the Town of Birdsong; and

WHEREAS, the City Council of Birdsong unanimously adopted the following resolution;

BE IT RESOLVED AS FOLLOWS:

"The Town of Birdsong does hereby accept the following described annexed property to the Town of Birdsong, the property being described as follows:

The Northwest One Quarter of the Northeast One Quarter (NW% NE%) of Section 29, Township 10 North, Range 8 East.

A Lot lying in the Southwest One Quarter of the Northeast One Quarter $(SW^{\frac{1}{4}} NE^{\frac{1}{4}})$ Section 29, Township 10 North, Range 8 East, and more particularly described as follows:

Commencing at the Northwest corner of the SW1 NE1, Section 29, Township 10 North, Range 8 East, Mississippi County, Arkansas; thence East and along the North line of the SW4 NE4 Section 29, a distance of 385.68 feet to the point of beginning; thence continue East and along said North line of the SW4 NE4, Section 29, a distance of 920.0 feet to a point, point being in the Northeast corner of the SW4 NE4 Section 29; thence South and along the East line of the SW4 NE4, Section 29, a distance of 355.10 feet to a point; thence West and parallel to the North line of the SW4 NE4 Section 29, a distance of 920.0 feet to a point; thence North and parallel to the East line of the SW_4^1 NE_4^1 , Section 29, a distance of 355.10 feet to the point of beginning. Containing 7.50 acres more or less according to a plat filed in Survey Book I, page 40, Osceola District of Mississippi County, Arkansas.

BE IT FURTHER RESOLVED, that the Mayor and/or the Clerk of the Town of Birdsong shall deliver a certified copy of this Resolution to the County Clerk requesting the County Clerk to certify one (1) copy of the plat of the annexed territory and one (1) copy of the Order of the Court along with this Resolution.

BE IT FURTHER RESOLVED, that the County Clerk be requested to forward a copy of the certified Order of the Court, and Resolution of the council to the Secretary of State to file and preserve them and one (1) copy of the plat of the annexed territory and a copy of the Order and the Resolution to the Director of Tax Division of the Arkansas Public Service Commission for filing, and further requests the County Clerk to notify all utility companies of the property in Birdsong, of the annexation.

BE IT FURTHER RESOLVED, that the Mayor and/or City Clerk shall request the County Clerk forward a certified copy of the Order of the Court to the council.



Now on this 6th day of February, 1996 is presented to the court the petition of J. M. Speck and Earl Pettigrew, signers of the petition for the annexation of certain territory to the Town of Birdsong, Arkansas, said territory being more particularly described herein:

The Northwest One Quarter of the Northeast One Quarter (NW $\frac{1}{2}$ NE $\frac{1}{2}$) of Section 29, Township 10 North, Range 8 East.

A Lot lying in the Southwest One Quarter of the Northeast One Quarter (SW4 NE4) Section 29, Township 10 North, Range 8 East, and more particularly described as follows:

Commencing at the Northwest corner of the SW¼ NE¼, Section 29, Township 10 North, Range 8 East, Mississippi County, Arkansas; thence East and along the North line of the SW¼ NE¼ Section 29, a distance of 385.68 feet to the point of beginning; thence continue East and along said North line of the SW¼ NE¼, Section 29, a distance of 920.0 feet to a point, point being in the Northeast corner of the SW¼ NE¼ Section 29; thence South and along the East line of the SW¼ NE¼, Section 29, a distance of 355.10 feet to a point; thence West and parallel to the North line of the SW¼ NE¼ Section 29, a distance of 920.0 feet to a point; thence North and parallel to the East line of the SW¼ NE¼, Section 29, a distance of 920.0 feet to a point; thence North and parallel to the East line of the SW¼ NE¼, Section 29, a distance of 355.10 feet to the point of beginning. Containing 7.50 acres more or less according to a plat filed in Survey Book I, page 40, Osceola District of Mississippi County, Arkansas.

Speck and Earl Pettigrew, exhibits attached thereto, publication of Notice of Hearing in the time and in the manner required by Arkansas Code Annotated 14-40-602, statements of counsel for the petitioners, Janet Moore-Hart, from all of which and other matters, proof and things before the Court, the Court finds as follows:

- 1. The Court finds that the requirements for signatures under Arkansas Code Annotated 14-40-601 have been complied with.
- 2. The Court finds that the limits of the territory to be annexed have been accurately described and that an accurate map thereof has been made and filed with this Court.
- 3. The Court finds the petitioners have published the Notice required by Arkansas Code Annotated 14-40-602 in the time and in the manner required by law.
- 4. That the petitioners request for annexation is right and proper and that this Court should enter an Order annexing the territory to the Town of Birdsong, Arkansas.


