ORDINANCE NO. 2001-1-125

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF JASPER, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF JASPER, ARKANSAS AND ASSIGNING SAME TO WARD(S)

WHEREAS, a petition was filed with the County Clerk of Newton County, Arkansas by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to and made a part of the City of Jasper, Arkansas, and

WHEREAS, on January 3, 2001, the County Court of Newton County, Arkansas found that the petition was signed by a majority of the real estate owners in said territory and that said territory was contiguous and adjoining the present corporate limits of the City of Jasper, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Jasper, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order,

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JASPER, ARKANSAS:

<u>Section 1</u>: That the following described lands and territory contiguous and adjoining the City of Jasper, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Jasper, Arkansas;

Recorded and Book 1 # 233 A part of the SE¹ of the NE¹ of Section 27, Township 16 North, Range 21 West, Newton County, Arkansas, described as follows: From a 1/2 inch iron rod at the Southwest corner of said SE of the NEX; go along the West line North 00°15'39" East 570.14 feet, leaving the West line go East 28.24 feet to a gum tree at a fence corner, point of beginning of the tract being described; then go along the fence North 00°00'29" West 772.21 feet; South 85°33'16" East 1347.33 feet to the East line of said SE1 of the NE1; go along the line South 01°50'40" West 482.51 feet to a point in the center of County Road 136; go along the road with the following movements: South 30°01'25" 3.08 feet; South 03°44'20" West 387.75 feet; South 25°07'09" West 21.84 feet; South 58°12'16" West 27.01 feet; South 81°41'20" West 364.74 feet; South 83°41'30" West 323.65 feet; South 56°14'50" West 38.51 feet; South 09°12'09" West 45.33 feet; South 11°58'31" East 90.26 feet to a point in the center of a creek branch; leaving the road to North 44°55'01" West 350.86 feet to a fence; then go along the fence North 50°10'41" west 226.35 feet; North 57°14'21" West 171.87 feet to the point of beginning. Containing 29.70 acres and being subject to an easement for public access along County Road 136.

That the above described territory shall be Section 2: annexed to and made a part of Ward _____ of the City of Jasper Arkansas and the same shall henceforth be a part of said ward as fully as fully as existing parts of said ward. Passed and approved this 15 day of Jelyuary , 2001.
