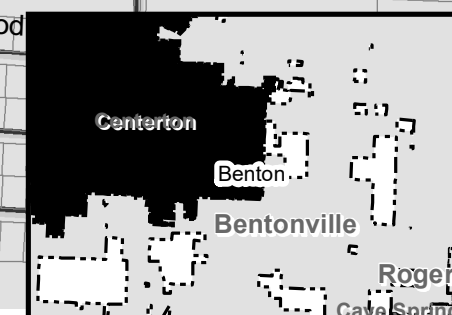
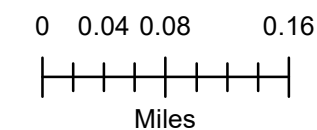

**AN ORDINANCE ACCEPTING AND ANNEXING CERTAIN LAND BELONGING TO ARC CONSTRUCTION AND DEVELOPMENT, INC., GARY DON CLINE AND KATHLEEN CLINE, AND ROSS BULL, ET AL TO THE CITY OF CENTERTON, ARKANSAS; ASSIGNING SAME TO WARD 3; AND FOR OTHER PURPOSES.**

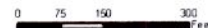
