

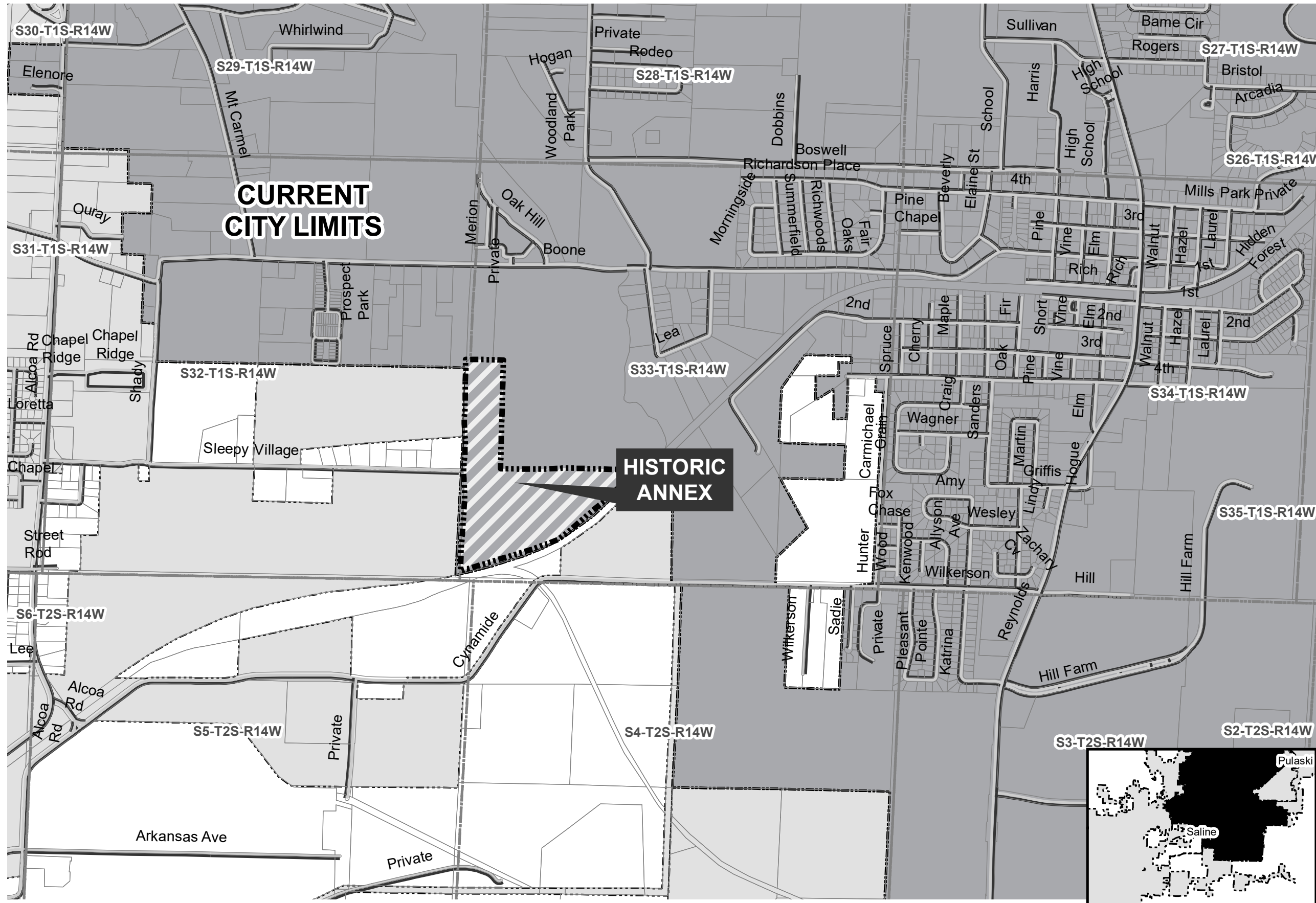

PETITION FOR ANNEXATION

Comes the undersigned and for its Petition states:

1. That Petitioner is the owner of the hereinafter described property, situated in Saline County, Arkansas, to-wit:

A tract of land comprising part of the SW ¼ of Section 33, Township 1 South, Range 14 West, Saline County, Arkansas, being more particularly described as follows:

Beginning at the Northwest Corner of the SW ¼ of said Section 33; thence east approximately 275 feet along the north line of the SW ¼ of said Section 33 to an Alcoa Property Corner; thence south along the Alcoa Property Line to an Alcoa Property Corner on the north line of the S ½ of the SW ¼ of said Section 33, said property corner being approximately 275 feet east of the Northwest Corner of S ½ of the SW ¼ of said Section 33; thence east along the north line of the S ½ of the SW ¼ to the northern right-of-way of the Union Pacific Railroad; thence southwesterly along said northern right-of-way of the Union Pacific Railroad approximately 1,645 feet to the Alcoa Property Line in the SW ¼ of the SW ¼ of said Section 33; thence north approximately 105 feet along the Alcoa Property Line to an Alcoa Property Corner in the SW ¼ of the SW ¼ of said Section 33; thence southwesterly along the Alcoa Property Line to the west line of the SW ¼ of said Section 33; thence north along said west line to the Point of Beginning, and containing approximately 45 acres, more or less.


2. The areas to be annexed are to include all adjacent and abutting public streets and rights-of-way.
3. Petitioner respectively requests this Court to enter an order annexing the above described real property to the City of Bryant, Saline County, Arkansas; that said land be made a part thereof, and that a date for hearing of the Petition be set and notice thereof be published as provided by law.
4. That said land is adjacent and contiguous to the City of Bryant, Saline County, Arkansas, a plat of said land being hereto attached and made a part hereof as Exhibit A.

5. Petitioner designates Brian Rosenthal, Rose Law Firm, a Professional Association to act on its behalf.

WHEREFORE, Petitioner prays the court that this Petition be granted and that the above described real property be annexed to and made a part of the City of Bryant, Saline County, Arkansas.

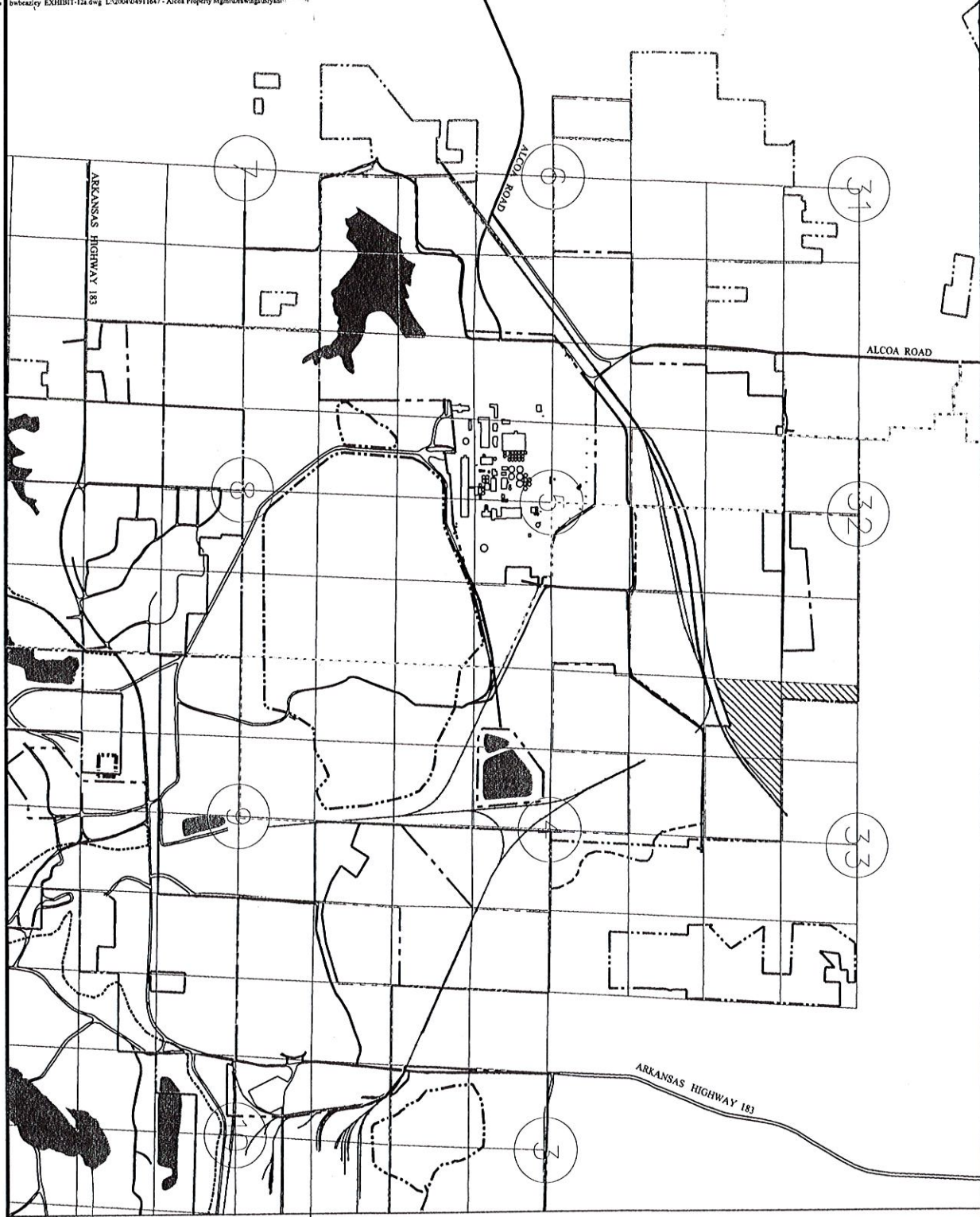
