



## ORDINANCE NO. 7 OF 2007

C-2006-194

2007 MAR 28 PM 2: 5 | AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF CABOT,

LONOKE COUNTY CLERKARKANSAS AND MAKING SAME A PART OF THE CITY DAWN PORTERFIELD OF CABOT, ARKANSAS, AND ASSIGNING SAME TO WARDS?

BY Polo Worde 10 CDECLARING AN EMERGENCY, AND FOR OTHER PURPOSES.

WHEREAS, a Petition was filed on the 12th day of December 2006, with the County Clerk of Lonoke County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Cabot, Arkansas; and

WHEREAS, on the 16<sup>th</sup> day of January 2007, the County Court of Lonoke County, Arkansas, found that the Petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Cabot, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Cabot, Arkansas, subject to the acceptance of said by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said Order of Annexation made by the County Court has expired and no appeal has been taken from said Order.

### NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CABOT, ARKANSAS THAT:

SECTION 1: That the following described lands and territory contiguous and adjoining the City of Cabot, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Cabot, Arkansas.

Lot 1, SYLVANIA ADDITION, part of the SE¼, Section 27, T-4-N, R-10-W, Lonoke County, Arkansas, as more fully described in Exhibit "A".

SECTION 2: That the above described territory shall be annexed to and made a part of Ward 1 of the City of Cabot, Arkansas, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

SECTION 3: That the city land use plan shall reflect the classification of the above described property as a C-2 zone.

SECTION 4: The proper use of and the annexing of lands is of great importance to the City of Cabot, and this Ordinance being necessary for the immedia


