

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF AUGUSTA, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF AUGUSTA AND ASSIGNING SAME TO THE WARD

WHEREAS, a petition was filed with the County Clerk of Woodruff County, Arkansas by the majority of the real estate owners of the property described hereinbelow, praying that the property be annexed to and made a part of the City of Augusta, Arkansas; and

WHEREAS, on the 11th day of August, 1994, the County Court of Woodruff County, Arkansas found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Augusta, Arkansas; that an accurate plat map of said territory had been filed with and made a part of the petition; that proper notice had been given for the time and in the manner prescribed by law; and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Augusta, Arkansas, subject to the acceptance of same by the City Council of Augusta; and,
