

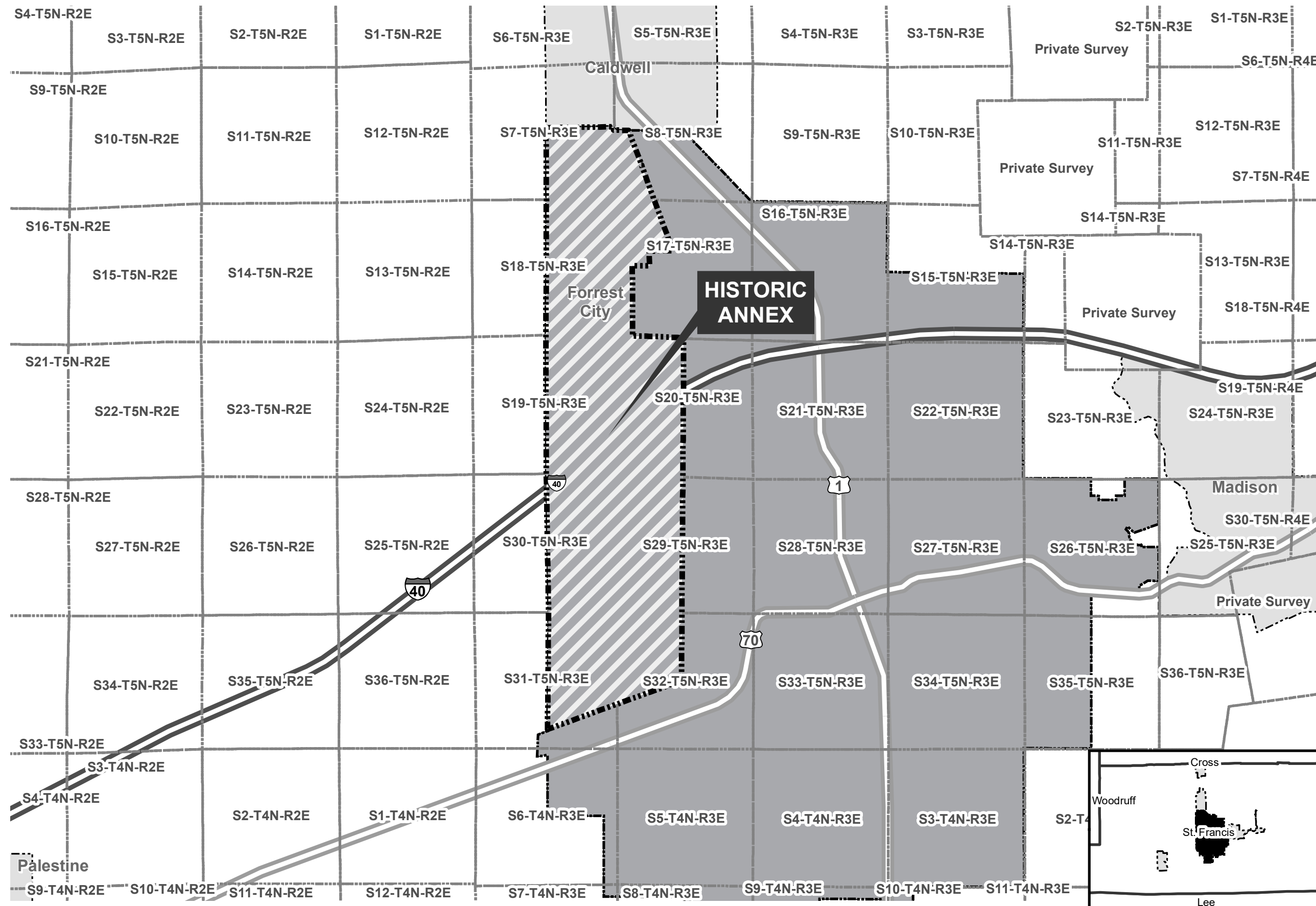

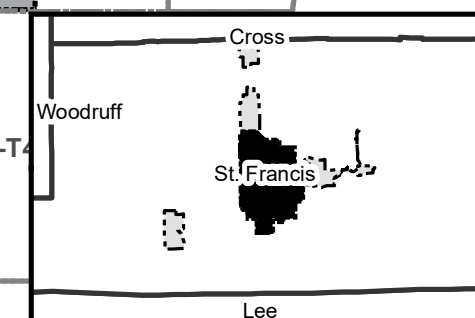
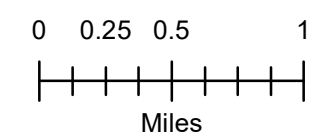
Arkansas Code 14-40-101.

ORDINANCE NO.

1842

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN REAL PROPERTY TO THE CITY OF FORREST CITY, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF FORREST CITY, AND ASSIGNING SAME TO WARDS.

WHEREAS, a Petition was filed with the Clerk of St. Francis County, Arkansas, by the majority of the real estate owners of the property described herein praying that said real property be annexed to, and made a part of the City of Forrest City, Arkansas; and

WHEREAS, on October 7, 2008, the County Court of St. Francis County, Arkansas, found that the Petition was signed by a majority of the owners of said real property; that said property was contiguous and adjoining the present corporate limits of the City of Forrest City, Arkansas; that an accurate map or plat of said real property had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said real property should be annexed to and made a part of the City of Forrest City, Arkansas, subject to the acceptance of same by the City Council at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORREST CITY, ARKANSAS:

Section 1. That the following described real property contiguous and adjoining the City of Forrest City, Arkansas, be, and the same hereby is, accepted as part of and annexed to the City of Forrest City, Arkansas:

Property to be annexed by the City of Forrest City in Sections 7, 8, 17, 18, 19, 20, 29, 30, 31, and 32, T5N-R-3E, St. Francis County, Arkansas.

Beginning at the intersection of the North line of the Southwest Quarter (SW ¼) of Section 8, T5N-R3E, St. Francis County, Arkansas and the centerline of the Missouri Pacific Railroad, thence West along the North line of said SW ¼, Section 8 to the Northeast Corner of the Southeast Quarter (SE ¼) of Section 7; thence North approximately 152.0 feet along the East line of the Northeast Quarter (NE ¼) of said Section 7 to the Northeast Corner of property recorded in Deed Book 420 at Page 680 of the Records of St. Francis County, Arkansas; thence West along the North line of properties recorded in Deed Book 420 at Page 680 and Deed Book 773 at Page 231 of the Records of St. Francis County, Arkansas to a point on the West line of the Northeast Quarter (NE ¼) of Section 7; thence South along the centerline of Section 7, 18, 19, 30 and 31 to a point of intersection with the North right of way line of the Union Pacific Railroad; thence Northeasterly along the North right of way of the Union Pacific Railroad to a point of intersection with the centerline of Section 32; thence North along the centerline of Sections 32, 29, and 20 to a point on the South line of Section 17; thence West along the South line of the Southwest Quarter (SW ¼) of Section 17 to a point lying 680 feet East of the Southwest Corner of said SW ¼, Section 7; thence North along a line parallel to and 680 feet East of a West line of Section 17 to a point on the North line of the Southwest Quarter (SW ¼) of Section 17; thence East along the North line of said Southwest Quarter SW ¼ to the Southwest Corner of the Southeast Quarter (SE ¼) of the Northwest Quarter (NW ¼) of Section 17; thence North along the West line of the SE ¼, NW ¼; thence East along the North line of the S ½, SE ¼, NW ¼, Section 17 to the point of intersection with the centerline of the Missouri Pacific Railroad; thence Northwesterly along the centerline of the Missouri Pacific Railroad to the point of beginning of the tract herein described.

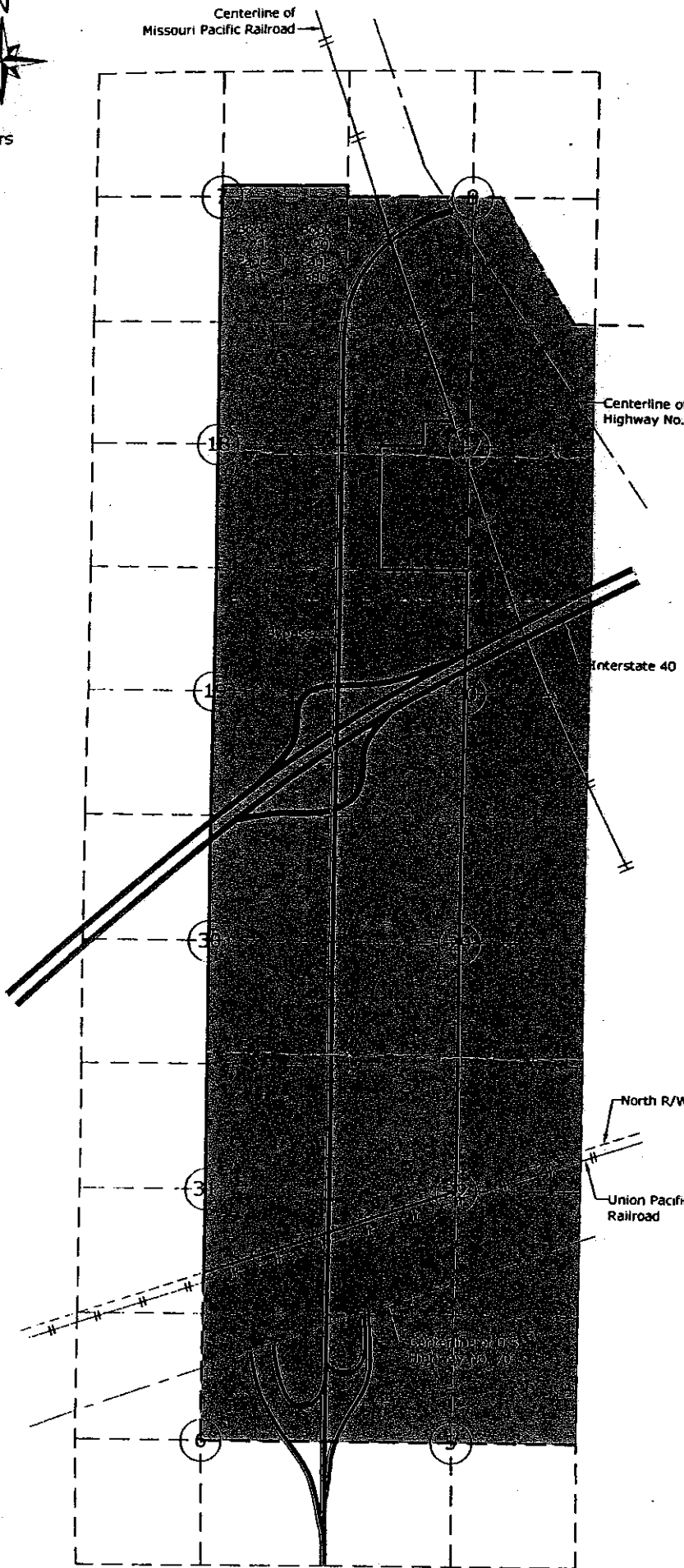
Centerline of Missouri Pacific Railroad
