

ORDER

Now on this 1st day of October, 1973, comes on to be heard the petition of Paul Walker, et al, for the annexation of certain territory to the Incorporated Town of Strawberry, Arkansas. And it appearing to the Court that notice of this hearing has been given for three consecutive weeks by publication in the Times Dispatch, a weekly newspaper published at Walnut Pidge, Arkansas, and having a bona fide circulation in the Incorporated Town of Strawberry, Arkansas, as provided by law.

That Leon Clinton, et al, appeared in open Court as remonstrants and objected to certain territory being included: that the objections of remonstrants should be sustained and their lands should be excluded from annexation.

The Court further finds that a majority of the property owners in the area to be included have signed said petition; that the limits of the proposed annexation and the territory therein are accurately described in said petition and a plat thereof has been filed with said petition: that the lands that should be annexed to said town are described as follows:

The East ten acres of the Worthwest Quarter (NWL) of the Mortheast Quarter (NEL) of Section Four (4). Township Fifteen the Southeast Quarter (SEL) of Cention Four (4) Township Fifteen (15) North, Range Three (3) Mest; the Southeast Quarter (SEL) of the Southeast Quarter (SEL) of Section Four (4), Township Fifteen (15) North, Range Three (3) Mest; and all that part of the Morth-east Quarter (MEL) of the Morthwest Quarter (MML) of Section Four (4), Township Fifteen (15) North, Range Three (3) Mest, Tyling West of road; the Southeast Quarter (SEL) of the Southwest Quarter (SEL) of the Southwest Southwest Corner of the Southeast Quarter (SEL) of the Southwest Southwest Corner of the Southeast Quarter (SEL) of the Southeast Quarter (SEL) of Section Six (6), Township Fifteen (15) North, Range Three (3) West, less and except one acre square in the Southwest Corner of said ten acre plot; the North Half (N) of the Northeast Quarter (NE%) of Section Seven (7), Township Fifteen (15) North, Range Three (3) West: the Northwest (9), Township Fifteen (15) North, Range Three (3) Nest; the Northwest Quarter (NW%) of the Southeast Quarter (SE%) of the Northwest Quarter (NW%) of Section Fight (8), Township Fifteen (15) North, Range Three (3) West; the South Half (S%) of the South Half (S%) of the Northeast Quarter (NE%) of the Northship Fifteen (15) North, Range Three (3) West; and a strip of land 60 feet wide on the South side of the Northeast Quarter (NE%) of the Northwest Quarter (NE%) of Section Four (4), Township Fifteen (15) North, Range Three (3) West.

ORDINANCE APPROVING ANNEXATION OF CERTAIN TERRITORY TO THE INCORPORATED TOWN OF

Whereas, there has been presented to the Town Council of the Incorporated

## ORDER CONFIRMING ANNEXATION
