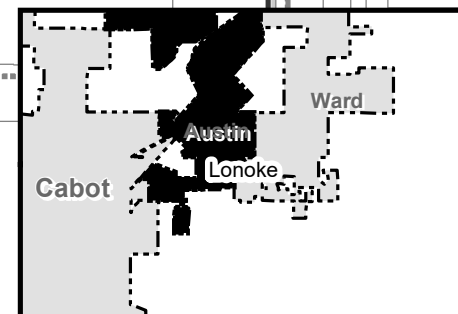
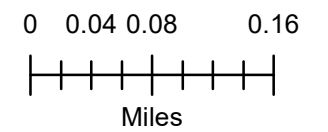

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF AUSTIN, ARKANSAS, AND MAKING SAME A PART OF THE TOWN OF AUSTIN, ARKANSAS.

WHEREAS, petition was filed with the County Clerk of Lonoke County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to and made a part of the Town of Austin, Arkansas.

WHEREAS, on the 8th day of March, 1993, THE county court of Lonoke, County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the Town of Austin, Arkansas; that an accurate plat or map of said territory had been filed with, and made a part of said petition; that proper notice had been given for the time and in the manner done in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that lands and territory should be annexed to and made a part of the TOWN OF AUSTIN ARKANSAS, subject to the acceptance of same by the TOWN COUNCIL OF said Town at the proper time, as provided by law; and,

Whereas, the time fixed by law for appealing from said order of annexation made by the COUNTY COURT has expired and no appeal has been taken from said order,

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF AUSTIN, ARKANSAS:

SECTION 1. That the following described lands and territory contiguous and adjoining the TOWN OF AUSTIN, ARKANSAS, be and the same is hereby accepted as part of and annexed to and made a part of the TOWN OF AUSTIN.

SECTION 2. That the above described territory shall be annexed to and made a part of TOWN OF AUSTIN, ARKANSAS, and the same shall henceforth be a part of AUSTIN, as fully as existing parts of AUSTIN.
