

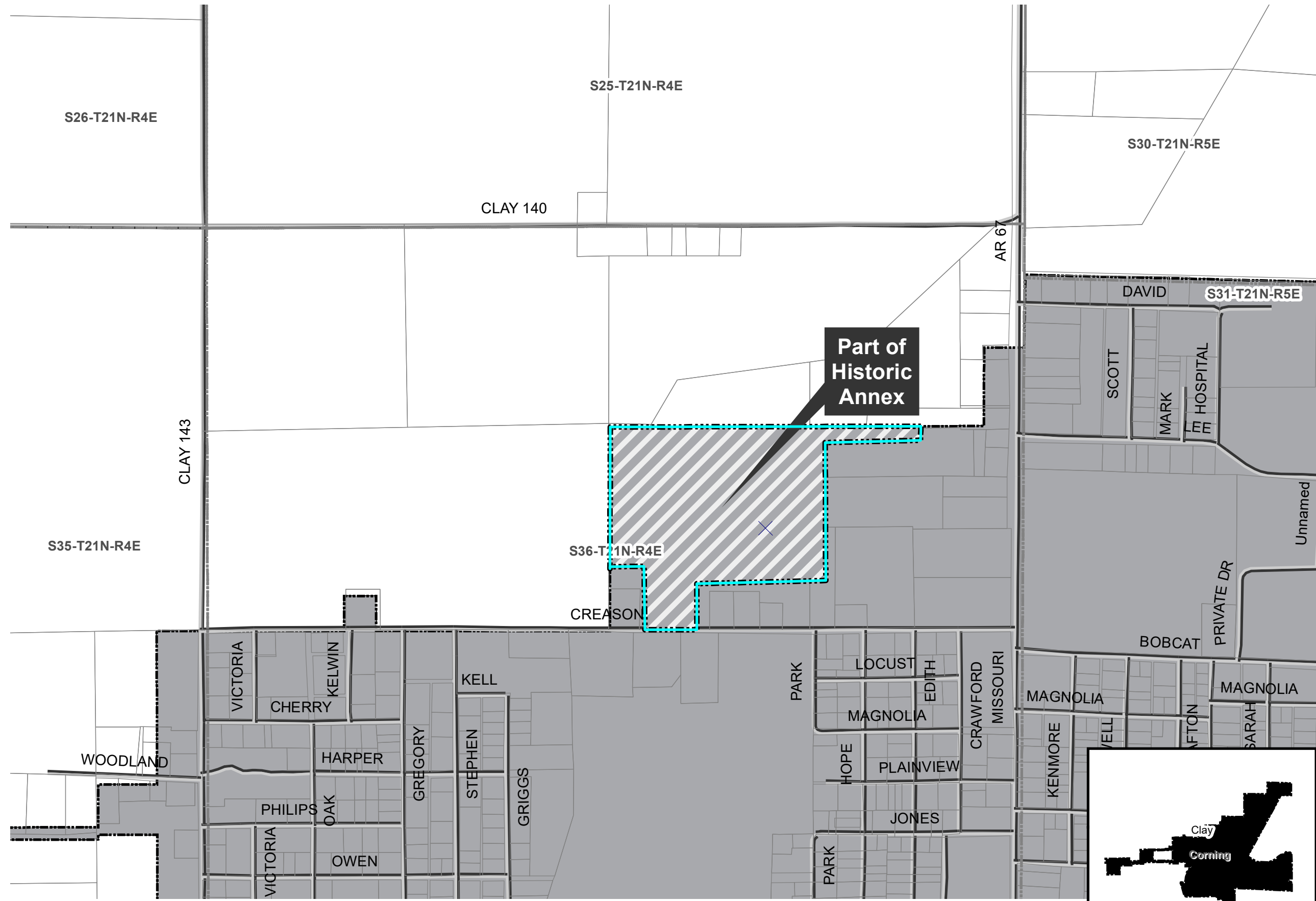

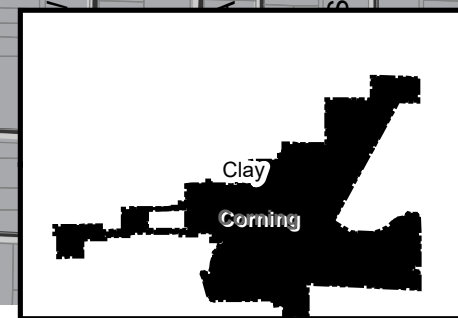
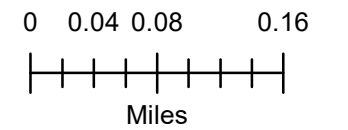

All of Lafferty Subdivision and 200 feet from, off and across the entire North side of the NE 1/4 of Section 3, Township 20 North, Range 4 East; and,



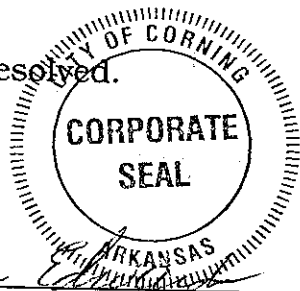

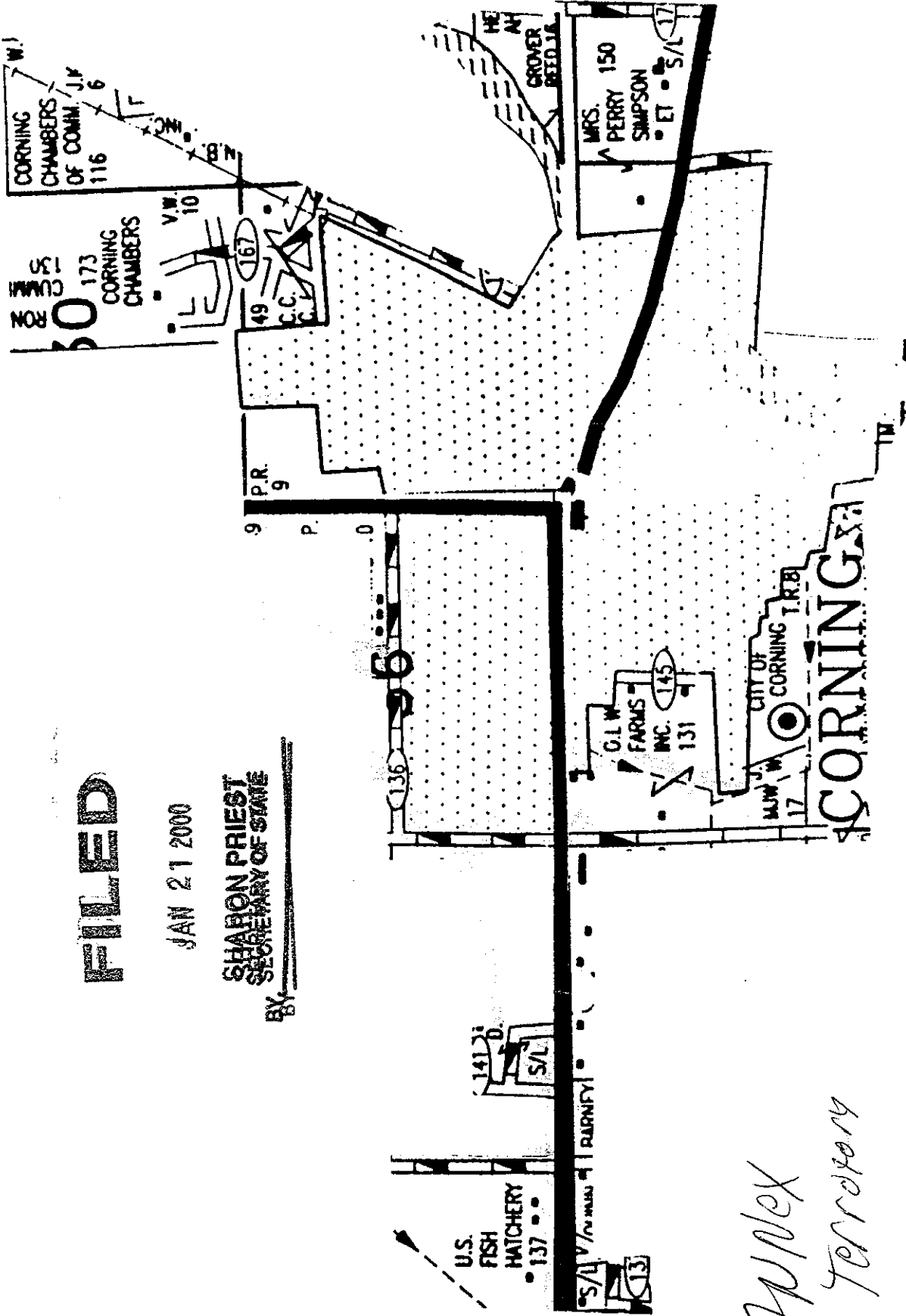
