

On this the 1st Day of December, 1969, the above entitled cause of action coming of the behard and having been submitted to the Court upon the verified potition of the Petitioners, with their sworn statement thereto, notice of Petition for Annexation with Proof of Publication thereof in the Salem Headlight, a weekly newspaper having a bonafide circulation for and within Fulton County, Arkansas for the time required by law, the statements of E.
