ORDER

On this the 9th day of June, 1978, comes on to be heard the petition of the Town Council of the Town of Reed, Arkansas, that the hereinafter described territory be annexed and joined to the Town of Reed, Arkansas, to-wit:

A parcel of land in the Northeast Quarter of the Southwest Quarter (NE \pm SW \pm) of Section 31, (which subdivision is also described as Lot 6 in the West Half (W \pm) of Section 31, on the original Government survey), lying East of U. S. Highway No. 65, in Township 11 South of the Base Line in Range 3 West of the 5th P. M., described as follows: Beginning at the Northeast corner of the SW \pm of Section 31, Township 11 South, Range 3 West, thence West along the one-half section line of said Section, 693 feet to intersection of east right-of-way of U. S. Highway No. 65, thence in a southerly direction along and on said east side of said right-of-way of U. S. Highway No. 65 to a point where the same intersects the north edge of a public dirt road (which leads in a general east and west direction at this point), thence east along the north edge of said public road 525 feet, thence North 543 feet to the point of beginning, containing 8.1 acres. The above shown by Plat B, appearing at page 150 of Plat Book 2 of Desha County plat records, subject to easements for roads, drainage ditches and public utilities.


And it appearing to the Court that notice of said hearing has been given for three (3) consecutive weeks by weekly publication in the Dumas Clarion, a newspaper of general circulation in the Arkansas City District of Desha Coutny, Arkansas; that said territory as above described is contiguous to and adjoins the corporate limits of the Town of Reed Arkansas. That said lands are owned by the Town of Reed, Arkansas, and that the petitioners herein comprise the Town Council of the Town of Reed, Arkansas; that the limits
