

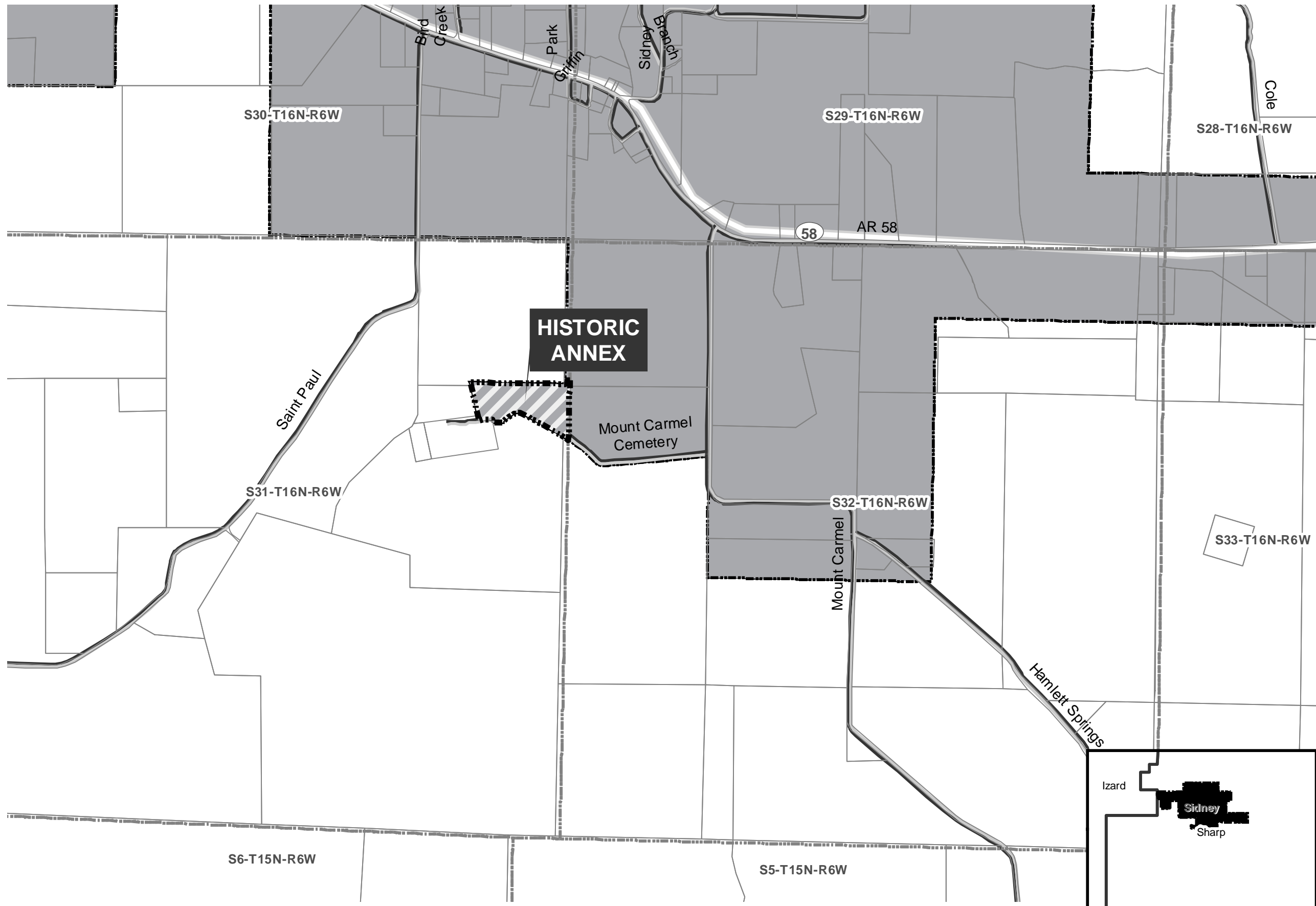

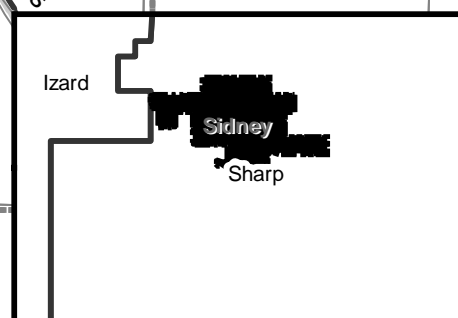
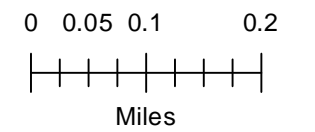

ORDINANCE APPROVING ANNEXATION

WHEREAS, there has been presented to the Town Council of the Town of Sidney and Order of Annexation duly executed by the County Judge of Sharp County authorizing the Annexation of certain territory to the Town of Sidney, it appearing that more than a majority of the inhabitants of the area being annexed signed a petition asking to be annexed into the Town of Sidney; that a plat as required by law was filed in the County Court of Sharp County and that the Mayor and City Council approves of said annexation; and
