AN ORDINANCE TO AMEND ORDINANCE NO. 6 RELATING TO THE DATES OF HOLDING ELECTIONS FOR THE OFFICER OF THE CITY BE IT ORDAINED BY THE CITY COUNCIL OF GREERS FERRY, ARKANSAS:

SECTION 1: THAT SECTION 4 OF ORDINANCE NO. 6 OF THE ORDINANCES OF THE CITY OF GREERS FERRY, ARKANSAS, IS HEREBY AMENDED TO READ AS FOLLOWS:

"ON THE TUESDAY FOLLOWING THE FIRST MONDAY OF NOVEMBER, 1970, AND EVERY FOUR (4) YEARS THEREAFTER, THERE SHALL BE AN ELECTION FOR MAYOR. ON THE TUESDAY FOLLOWING THE FIRST MONDAY IN NOVEMBER, 1970, AND EVERY TWO (2) YEARS THEREAFTER THE ELECTION OF ALL OTHER OFFICIALS OF THE CITY OF GREERS FERRY, ARKANSAS, SHALL BE HELD, PROVIDED, BEGINNING WITH THE ELECTION IN NOVEMBER, 1972, THE CITY RECORDER SHALL BE ELECTED FOR A FOUR (4) YEAR TERM. ALL OFFICERS ELECTED IN NOVEMBER OF ANY YEAR SHALL TAKE OFFICE ON JANUARY 1st OF THE FOLLOWING YEAR."

SECTION 2: THIS AMENDMENT BEING NECESSARY FOR THE ORDERLY ADMINISTRATION OF GOVERNMENT AND FOR THE PUBLIC PEACE, HEALTH AND WELFARE, AN EMERGENCY IS DECLARED TO EXIST AND THIS AMENDMENT SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE AND POSTING OR PUBLICATION AS REQUIRED BY LAW.

The errors in the legal description and plat map of the city were discovered only recently when the city map put out by the Arkansas Highway Department was received by the City Council.

There are four errors in all. The first error is in the map itself—an area described by the legal description was inadvertently left off the map. The other three errors are in the legal description -- three areas drawn into the map and intended to be a part of the city were inadvertently left out of the

## AMENDMENT TO ORDINANCE NO. 6

AN ORDINANCE TO AMEND ORDINANCE NO. 6 RELATING TO THE NUMBER AND DESIGNATION OF WARDS IN THE CITY OF GREERS PERRY, ARKANSAS.

BE IT ORDAINED BY THE CITY COUNCIL OF GREERS FERRY, ARKANSAS:

SECTION 1: THAT SECTION 2 OF ORDINANCE NO. 6 OF THE ORDINANCES OF THE CITY OF GREERS FERRY, ARKANSAS, IS HEREBY AMENDED TO READ AS FOLLOWS:

"THAT THE CITY OF GREERS FERRY SHALL BE DIVIDED INTO
THREE (3) WARDS, EACH OF WHICH SHALL HAVE REPRESENTATION IN THE
CITY COUNCIL BY TWO (2) ALDERMEN TO BE ELECTED AS IS NOW PROVIDED
FOR BY LAW. SAID WARDS SHALL BE KNOWN RESPECTIVELY AS WARD 1,
WARD 2 AND WARD 3."

SECTION 2: THAT SECTION 3 OF ORDINANCE NO. 6 OF THE ORDINANCES OF THE CITY OF GREERS FERRY, ARKANSAS, IS HEREBY AMENDED TO READ AS FOLLOWS:

"THAT EACH OF THE THREE (3) WARDS AS HEREINABOVE DESIGNATED SHALL EMBRACE AND CONTAIN THE PROPERTIES AS SET FORTH AND DESCRIBED IN THE PLAT ATTACHED HERETO, A COPY OF WHICH SHALL BE FILED WITH THE ARKANSAS SECRETARY OF STATE."

SECTION 3: THAT TWO ALDERMEN FROM EACH OF THE THREE WARDS DESIGNATED ABOVE SHALL BE ELECTED AT THE GENERAL ELECTION HELD IN NOVEMBER OF 1972 AND SHALL TAKE OFFICE ON JANUARY 1, 1973, TO SERVE FOR A TERM OF TWO YEARS. THE TEN ALDERMEN PRESENTLY SERVING SHALL CONTINUE TO HOLD OFFICE UNTIL JANUARY 1, 1973.

SECTION 4: THIS AMENDMENT BEING NECESSARY FOR THE ORDERLY
ADMINISTRATION OF GOVERNMENT AND FOR THE PUBLIC PEACE, HEALTH AND
WELFARE, AN EMERGENCY IS DECLARED TO EXIST AND THIS AMENDMENT SHALL
BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE AND POSTING
OR PUBLICATION AS REQUIRED BY LAW.

AN ORDINANCE TO RAISE THE TOWN OF GREERS FERRY, ARRANSAS, TO A CITY OF THE SECOND CLASS, TO PROVIDE FOR THE ELECTION OF OFFICERS THEREAFTER, THE DESIGNATION OF WARDS, AND FOR OTHER PURPOSES.

BE IT CRDAINED BY THE TOWN COUNCIL OF GREERS FERRY, ARKANSAS:

7.--

SECTION 1. THAT AFTER THE PASSAGE, PUBLICATION AND APPROVAL OF THIS CROIMANCE AT AN ELECTION AS HEREINAFTER PROVIDED FOR, THE INCORPORATED TOWN OF GREERS FERRY, ARKANSAS, SHALL BE AND IS HEREBY DECLARED TO BE A CITY OF THE SECOND CLASS.

SECTION 2. THAT THE CITY OF GREERS FERRY SHALL BE DIVIDED INTO FIVE (5) WARDS, EACH OF WHICH SHALL HAVE REPRESENTATION IN THE CITY COUNCIL AS IS NOW PROVIDED FOR BY LAW, AND SAID WARDS SHALL BE KNOWN RESPECTIVELY AS THE FIRST (1ST) WARD THROUGH THE FIVE (5) WARDS INCLUSIVELY.

SECTION 3. THAT EACH OF THE FIVE (5) WARDS AS HEREIN ABOVE DESIGNATED SHALL EMERACE AND CONTAIN THE PROPERTIES AS SET FORTH AND DESCRIBED IN THE ORIGINAL PLAT NOW FILED OF RECORD, A PHOTOSTATIC COPY IS ATTACHED HERETO INCORPORATED HEREIN MADE A PART HEREOF, TO THE SAME DEGREE AND FOR INTENSE AND PUREOSES AS THOUGH COPIED AT LENGTH HEREIN.

SECTION 4: ON THE TUESDRY FOLLOWING THE MIRST HONDAY OF NOVEMBER, 1972, AND EVERY FOUR (A) YEARS THEREAFTER, THERE SHALL BE AN ELECTION FOR MAYOR. ON THE TUESDAY POSITION OF THE FIRST MONDAY IN NOVEMBER, 1972, AND RIENNIALLY THEREAFTER, THE ELECTION OF ALL OTHER OFFICIALS OF THE CITY OF GREERS FERRY SHALL BE HELD. BEGINNING WITH THE ELECTION IN ROVEMBER, 1972, THE CITY RECORDER WILL BE ELECTED FOR A FOUR (L) YEAR TERM. THE OFFICIALS ELECTED IN NOVEMBER, 1972, AND BIENNIALLY THEREAFTER WILL TAKE OFFICE ON JANUARY 1ST OF THE NEXT YEAR FOLLOWING THEIR ELECTION.

SECTION 5. THAT AFTER THE PASSAGE AND PUBLICATION OF THIS ORDINANCE, THE SAME SHALL BE SUBMITTED TO THE VOTE OF THE QUALIFIED ELECTORS OF THE TOWN OF GREERS FERRY ON THE 23RD DAY OF SEPTEMBER, 1969, AND AT THE PLACE OR PLACES, "LOCATION" AS MAY BE LEGALLY AND PROPERLY DESIGNATED, IT IS THE MUNICIPAL BUILDING OF GREERS FERRY, ARRANSAS, A SPECIAL ELECTION SHALL BE CALLED BY A PROCLAMATION OF THE MAYOR, AND IF A MAJORITY OF THE QUALIFIED ELECTORS VOTING IN SAID

BLECTION, VOTE IN FAVOR OF THIS ORDINANCE, A CERTIFIED COPY HEREOF SHALL BE FILED WITH THE SECRETARY OF STATE, MHEREUPON THE TOWN OF GREERS FERRY, ARRAMAN, SHALL BE DEEMED TO BE A CITY OF THE SECOND CLASS. THE PRESENT OFFICERS OF THE INCORPORATED TOWN OF GREERS FERRY, ARRAMAN, SHALL CONTINUE IN OFFICE AND UPON THE FILING OF A CERTIFIED COPY OF THIS ELECTION WITH THE SECRETARY OF STATE, THE OFFICERS SHALL BE DEEMED OFFICERS OF A CITY OF THE SECOND CLASS, ABLE TO DO AND PERFORM ALL DUTIES WHICH THE LAW PROVIDES, AND IN ACCORDANCE WITH THE BY-LAWS PROMULGATED AND ADOPTED BY THE CITY COUNCIL SO LONG AS THEY DO NOT CONTROVERT OR BE IN CONFLICT WITH THE LAWS OF THE STATE OF ARRANSAS, AND OR THE LAWS OF THIS THE UNITED STATES OF AMERICA.

SECTION 6. WHEREAS, IT IS NECESSARY FOR THE EFFICIENT AUMINISTRATION OF THE MUNICIPAL GOVERNMENT OF THE TOWN OF GREERS FERRY THAT IT SHOULD HAVE THE POWERS OF A SECOND CLASS CITY AND, WHEREAS, A DELAY IN RAISING THE CLASSIFICATION WILL RESULT IN THE LOSS OF MANY BENEFITS THAT CAN BE DERIVED AT THIS TIME FROM THE HIGHER CLASSIFICATION, AN EMERGENCY IS DECLARED TO EXIST AND THIS ORDINANCE BEING NECESSARY TO PRESERVE THE PUBLIC PEACE, HEALTH, SAFETY, AND EFFICIENCY THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER THE DATE, OF ITS PASSAGE.




