



ORDINANCE NO: 440

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF AUGUSTA, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF AUGUSTA, ARKANSAS, AND ASSIGNING PORTIONS OF THE PROPERTY TO SPECIFIC WARDS.

WHEREAS, a petition was filed with the County Clerk of Woodruff County, Arkansas by the majority of real estate owners of the property described hereinbelow praying that said property be annexed to, and made a part of the City of Augusta, Arkansas; and

WHEREAS, on the 17th day of June, 2002, the County Court of Woodruff County, Arkansas found that the Petition was signed by a majority of the real estate owners of said property; that said property was contiguous and adjoining the present corporate limits of the City of Augusta, Arkansas; that an accurate plat or map of said property had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law and that all things pertaining thereto had been done in the manner prescribed by law, and that said property should be annexed to and made a part of the City of Augusta, Arkansas subject to the acceptance of same by the city council of the City of Augusta, Arkansas at the proper time as provided by law; and

WHEREAS, Porters, Inc. as it relates to the western most tract of property that is the subject of this Ordinance is pursuant to law selling at retail beer, wine and liquor and it is the understanding of the city council of the City of Augusta that the law provides and A.C.A. 3^{-8-210} specifically allows for the sell of beer, wine and liquor pursuant to a preexisting permit notwithstanding that theOCT 4 2002 City of Augusta is considered to be a dry territory; and SHARON PRIEST SECRETARY OF STATE

WHEREAS, it is not the intention of the City of Augustaby virtue of this annexation to negatively affect the sale of beer, wine and liquor pursuant to the existing permit held by Porters, Inc.; and,

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL

OF THE CITY OF AUGUSTA, ARKANSAS:



Notice of a hearing on the petition was duly given in accordance with applicable law, and more than the statutory period have elapsed since the filing of the petition. A majority of the total number of real owners in the area effected by the petition have signed it and such majority owns more than one-half of the acreage effected.

The territory sought to be annexed was accurately described in an Exhibit to the petition and the territory is contiguous to the boundaries of this City of Augusta, Arkansas. An accurate map of the territory to be annexed was attached to the petition as an exhibit.

The City of Augusta has passed ordinance No. 408 enacted on

the 9th day of October, 1995, accepting the annexation of the territory on Exhibit A to the City of Augusta, Arkansas, and making it a part of the City, Zoned C1.

Finally, the Court finds that the prayer of the petition is right and proper in all respects; that due notice has been given in accordance with applicable law; and that the petition should be granted.

IT IS, THEREFORE, CONSIDERED, ORDERED, DECREED, that the territory more particularly described on Exhibit A attached hereto and made a part hereof, be and the same is hereby annexed to and made a part of the City of Augusta, Arkansas.

IT IS FURTHER ORDERED that the Clerk of Woodruff County Court record this Order and deliver certified copies thereof to the City of Augusta, Arkansas, the Secretary of State of the State of Arkansas, and the Director of the Tax Division of the Arkansas Public Service Commission.
