

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MURFREESBORO, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MURFREESBORO, AND ASSIGNING SAME TO WARDS

ORDINANCE NO. 199

WHEREAS, petition was filed with the County Clerk of Pike County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Murfreesboro, Arkansas, and,

WHEREAS, on the 29th day of July, 1996, the County Court of Pike County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Murfreesboro, Arkansas; that an accurate plat or map of said territory had been filed with, and made a part of said petition; that proper notice has been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of Murfreesboro, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MURFREESBORO, ARKANSAS.

Section 1. That the following described lands and territory contiguous and adjoining the City of Murfreesboro, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Murfreesboro:

All that part of the West Half of the Southwest Quarter (W $\frac{1}{2}$  SW $\frac{1}{4}$ ) of Section Four (4), lying West of Prairie Creek, containing 2 acres, more or less, All that part of the East Half of the Southeast Quarter (E $\frac{1}{2}$  SE $\frac{1}{4}$ ) of Section Five (5), lying West of Prairie Creek, containing 78 acres, more or less, and All that part of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section Five (5) which lies between the Right of Way of the abandoned M.D.&G Railroad and the East and South lines of the said described land, containing  $1\frac{1}{4}$  acres, more or less. All in Township Eight (8) South of the Base Line in Range Twenty-five (25) West of the Fifth Principal Meridian in Arkansas, and containing in the aggregate  $81\frac{1}{4}$  acres, more or less.

Section 2. That the above described territory shall be annexed to and made a part of the  $N_{or}+h$  Ward of the City of Murfreesboro, and the same shall henceforth be a part of said ward as fully as existing parts of said Ward.

Section 3. This Ordinance being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force and shall take effect upon passage and publication.


