

AMENDED ORDINANCE NO. 01-06

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY CONTIGUOUS TO THE CITY OF GLENWOOD, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF GLENWOOD, ARKANSAS, AND ASSIGNING SAME TO WARDS

WHEREAS, petition was filed with the County Clerk of Montgomery County, Arkansas, by the majority of real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Glenwood, Pike County, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Glenwood, Pike County, Arkansas, subject to the acceptance of same by the City council of said City at the proper time as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLENWOOD, PIKE COUNTY, ARKANSAS:

SECTION 1. That the following described lands and territory contiguous and adjoining the City of Glenwood, Arkansas, be and they same is hereby accepted as part of and annexed to and madesas Examples


