ORDINANCE NO. 2196

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MENA, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MENA, AND ASSIGNING SAME TO WARDS

WHEREAS, petition was filed with the County Clerk of Polk County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Mena, Arkansas; and

WHEREAS, on April 23, 2010, the County Court of Mena, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Mena, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said land and territory should be annexed to and make a part of the City of Mena, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the county court has expired and no appeal has been taken from said order.

NOW THEREFORE, be it ordained by the City Council of the City of Mena, Arkansas:

Section 1. That the following described lands and territory contiguous and adjoining the City of Mena, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Mena, Arkansas:
