COUNTY OF FRANKLIN

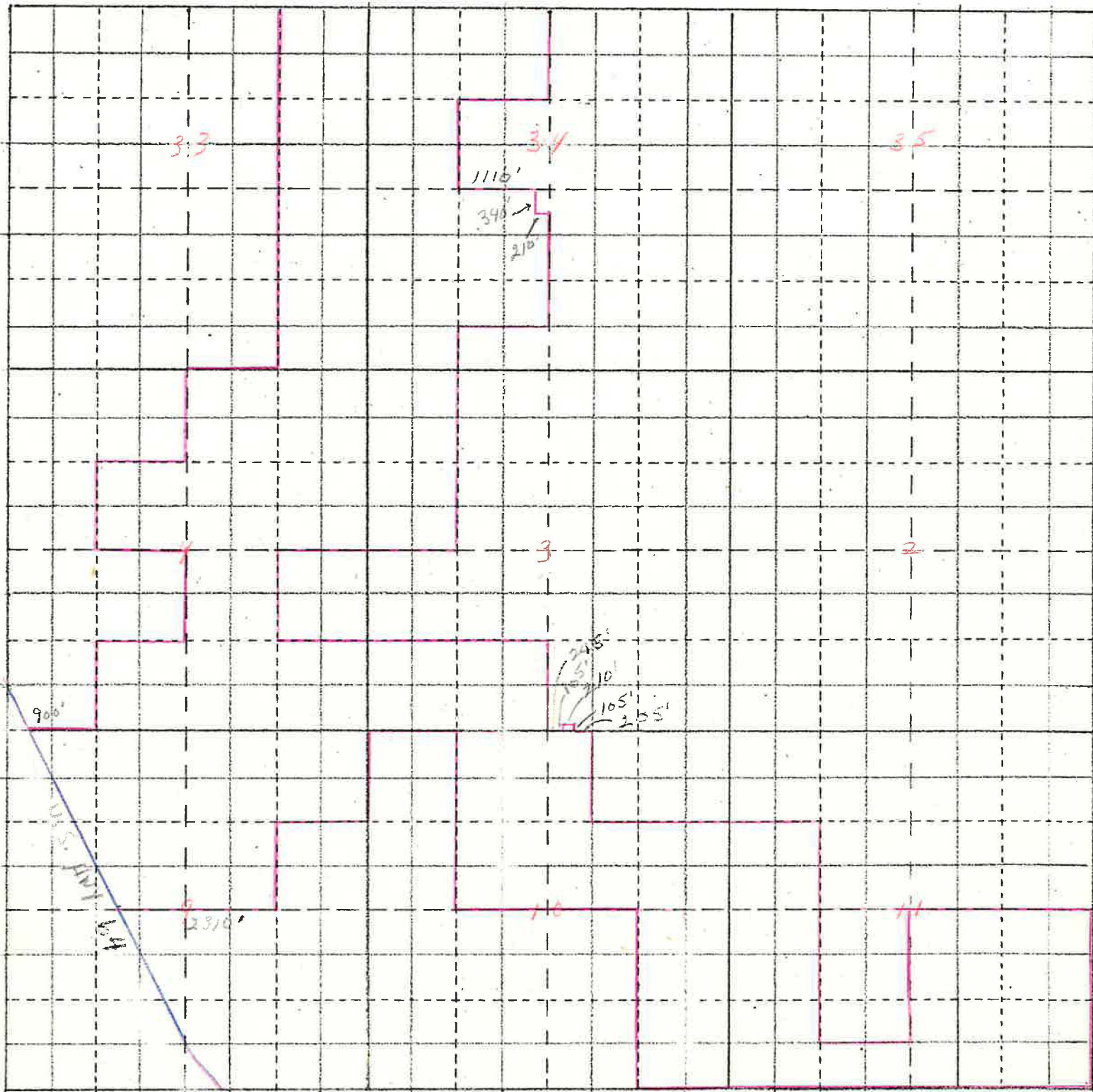

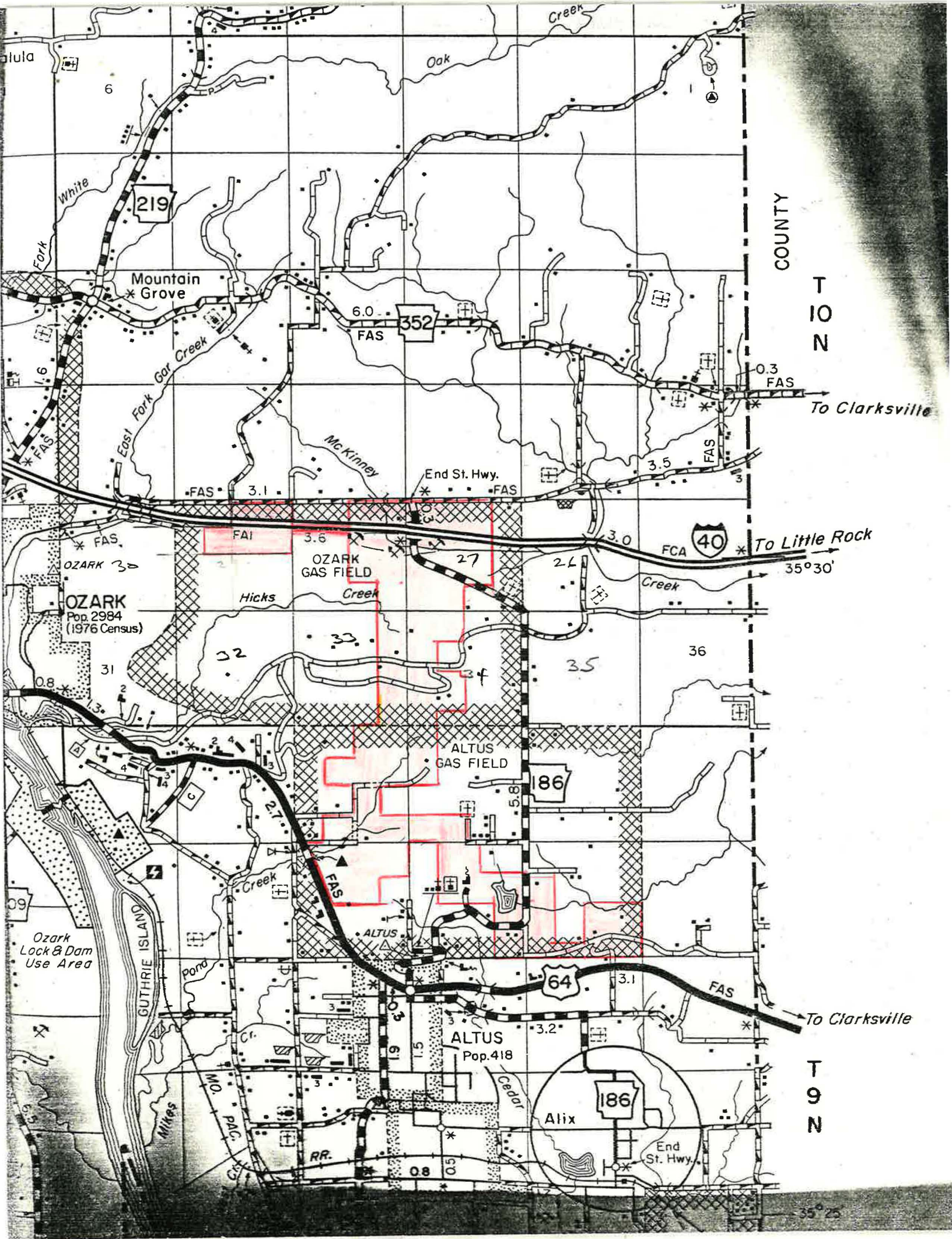

PETITION FOR INCORPORATION

TO THE COUNTY COURT OF FRANKLIN COUNTY, ARKANSAS:

We, the undersigned qualified voters and inhabitants of the territory hereinafter described, do respectfully request this Court to organize and incorporate a town under the name of Wiederkehr Village, to embrace the following territory in Franklin County, Arkansas, to-wit:
