**ORDER OF CONFIRMATION OF ANNEXATION**

Comes on for hearing the above-styled proceeding before the County Court of White County, Arkansas. The said Court being well and sufficiently advised in the premises finds:

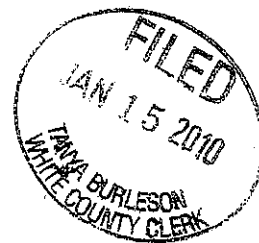
1. That this Court entered its Order for Annexation of certain territory as subscribed in the Petition of Annexation on July 20, 2009.
2. That pursuant to Arkansas Code Annotated Section 14-40-604, more than 30 days from and after the entry of the said Order of Annexation passed and no notice objecting to the said annexation or any other proceeding to prevent the said annexation was given or filed.
3. That the City Council for the City of Kensett, Arkansas has, by ordinance No. 2009-07 accepted the said territory pursuant to the requirements of Arkansas Code Annotated Section 14-40-605 (a).
4. That the City of Kensett referred the annexation to the electorate of the City of Kensett on April 13<sup>th</sup>, 2010. The results of said election were 191 in favor of annexation and 170 opposed to the annexation.

**AN ORDINANCE TO ACCEPT INTO THE CITY LIMITS OF THE CITY OF KENSETT, ARKANSAS, CERTAIN TERRITORY ANNEXED INTO THE KENSETT CITY LIMITS BY ORDER OF THE COUNTY COURT OF WHITE COUNTY, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES:**

Whereas, the City of Kensett, Arkansas petitioned the County Court of White County, Arkansas, to annex certain properties into the Kensett city limits, and

Whereas, the County Court of White County, Arkansas, on July 20, 2009, entered an order annexing certain properties into the Kensett city limits, and

Whereas, the City Council of the City of Kensett, Arkansas, desires to accept said properties and territory into the city limits of Kensett.

**NOW THEREFORE BE IT ORDAINED**, by the City Council for the City of Kensett, to-wit:

Section 1. The City Council of Kensett, Arkansas, hereby accepts into the city limits of Kensett, Arkansas, the following described territory:

**The South 25 feet of the NE ¼ of Section 18, Township 7 North, Range 6 West lying East of the West line of Jody Taylor Road and the North 25 feet of the SE ¼ of Section 18, Township 7 North, Range 6 West lying East of the West line of Jody Taylor Road.**

Section 2. That the Clerk of the County Court of White County, Arkansas, is hereby requested pursuant to A. C. A. § 14-40-605 to certify a copy of the plat of the annexed territory and one copy of the order of the County Court and to forward said certified copies along with a certified copy of this Ordinance to the Office of the Secretary of State for the State of Arkansas, and the Director of the Tax Division of the Arkansas Public Service Commission.

Section 3. It being hereby ascertained and declared that in as much as there is an immediate need to include the above described properties and territory into the city limits of the City of Kensett, Arkansas, for the purpose of providing city services to said properties and allow the orderly development of said properties under the applicable city codes that an emergency exists and this ordinance being necessary for the preservation of the public health, safety and welfare shall take effect from and after the date of its passage.

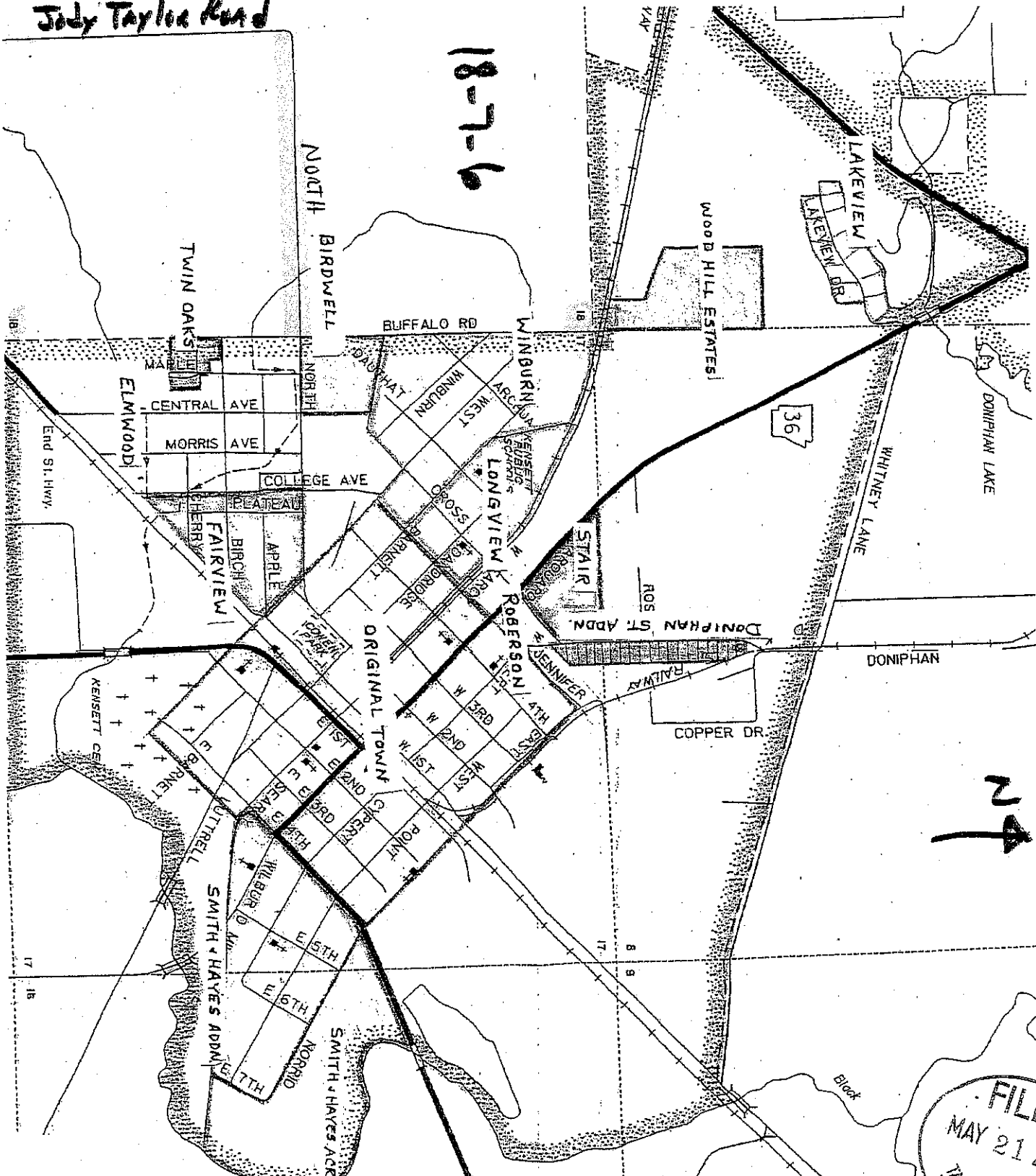

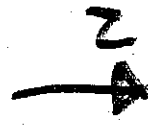
