SECTION 2: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: An emergency is hereby declared and this ordinance being necessary for the preservation of the public peace, health, and safety shall be in full force and effect from and after its passage.

### ORDER OF ANNEXATION


