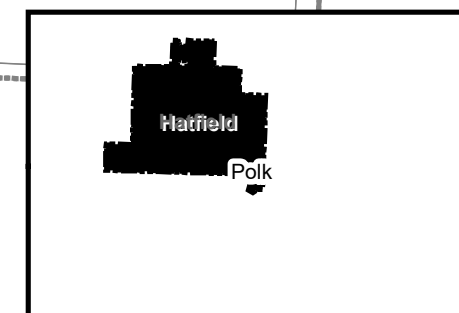
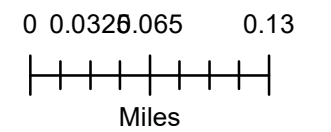



ORDINANCE NUMBER 1999-01

AN ORDINANCE CONFIRMING THE ANNEXATION OF ADJOINING LANDS TO THE TOWN OF HATFIELD, ARKANSAS AS PETITIONED BE THE OWNERS THEREOF.

WHEREAS, the Town Council of the Town of Hatfield, Arkansas, has conducted a public hearing in accordance with Arkansas law and determined that there is a need to confirm annexation of adjoining lands to the Town of Hatfield, Arkansas, and;

WHEREAS, the Town recognizes said lands as being described and platted as:

Tract 1

WHEREAS, the Town Council of the Town of Hatfield, Arkansas, has determined that a plat has been filed with said petition in the office of the Clerk of Polk County and the Court has granted the petition to annex said lands to the Town of Hatfield, Arkansas, County of Polk and has duly ordered, adjudged and decreed that said lands are now incorporated into the municipal corporation known and identified as the Town of Hatfield and all inhabitants of said lands have been granted the rights and privileges of residents of the Town of Hatfield, Polk County, Arkansas.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Hatfield, Arkansas as follows:

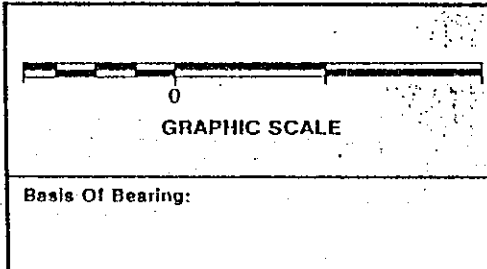
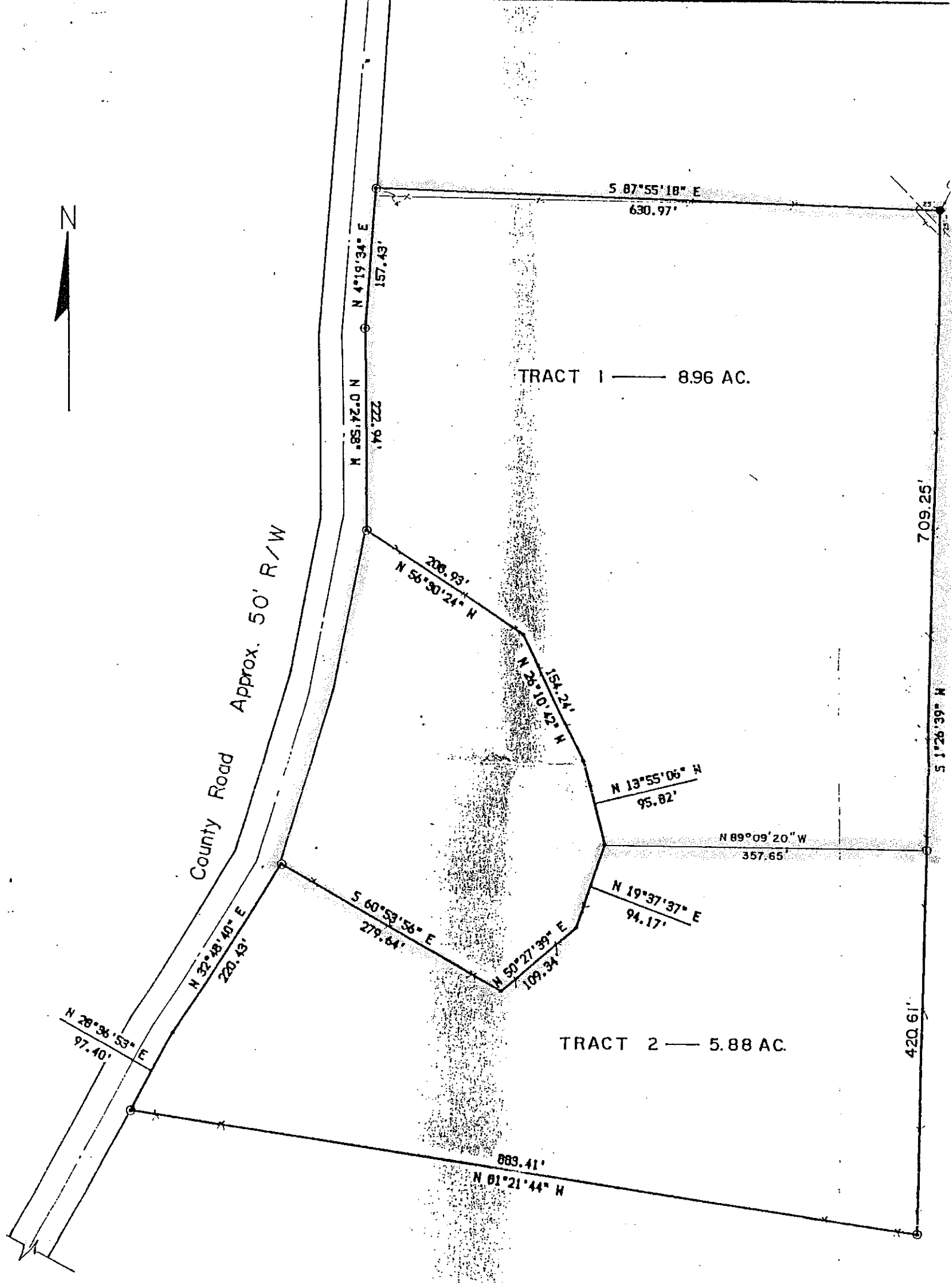

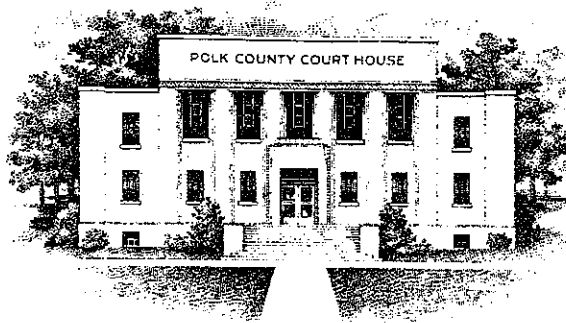
