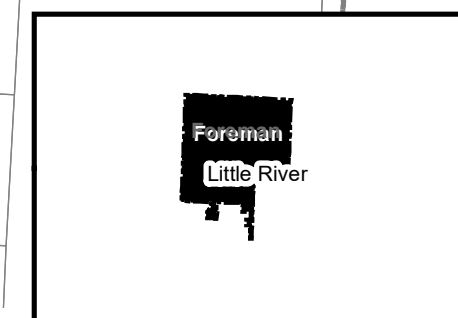
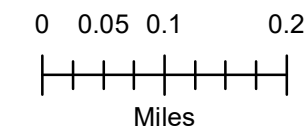

ORDINANCE NO. 130

AN ORDINANCE APPROVING AND ACCEPTING THE ANNEXATION
TO THE CITY OF FOREMAN, ARKANSAS, CERTAIN TERRITORY
CONTIGUOUS TO THE SAID CITY OF FOREMAN, ARKANSAS

WHEREAS, the County Court of Little River County,
Arkansas, entered its Order on November 8, 1978, upon the Petition
of Ras Meredith, Martha O. Meredith, Perry Clifton Young, Sallye
Young, James L. Jamison and Janice L. Jamison, being a majority
of the real estate owners who own more than one-half of the
property affected, after due notice of hearing on said Petition
for the time and in the manner prescribed by law, ordering the
annexation to the City of Foreman of the following described lands
located in Little River County, Arkansas:

Beginning at the SE Corner of Lot #2 of the SE-4
of SW-4 of Section 22, Twp. 12 S., Rge. 32 West,
said corner being 57 feet North of the Southeast
corner of the said SE-4 of SW-4, thence run North
0 degree, 24' West 379 feet, thence North 89 de-
grees 47' West 49 feet, thence North 0 degree 24'
West 52 feet for the point of beginning, thence
North 0 degree 24' West 823.5 feet to the North
line of Lot 2, thence North 89 degrees 47' West
355.9 feet to the East Right-of-Way line of Ar-
kansas Highway 108, thence Southwesterly with the
highway on a curve to the right 782.6', thence
Southeast on a straight line 587.5 feet to the
point of beginning, containing 7.5 acres, more or
less.

Southwesterly with the highway on a curve to the

feet to the SW corner of Lot 2, thence South 89
degrees 48' East 646.5 feet to the point of begin-
ning, containing 14.6 acres, more or less; Except
the following described tract: Beginning at the
Southeast corner of Lot 2 of the SE-4 of SW-4 of
Section 22, Twp. 12 South, Rge. 32 West, said cor-
ner being 57' North of the SE corner of said SE-4

Begin at the Southwest corner of SW-4 of NW-4 of Section 23, Township 12 South, Range 32 West and run North 530 feet to the point of beginning, thence North 100', thence East 420', thence South 100', thence West 420' to the point of beginning.

WHEREAS, said above described lands are contiguous to and adjoin the City of Foreman, Arkansas;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FOREMAN, ARKANSAS:

SECTION 1. That the City of Foreman, Arkansas, acting through this City Council, does hereby approve the annexation of, and does hereby accept and make a part of the incorporated area of the City of Foreman, Arkansas, all of the lands described hereinabove in this Ordinance.

SECTION 2. It is further ordered that said lands be, and they are hereby assigned and attached to and made a part of Ward Three of said City of Foreman.

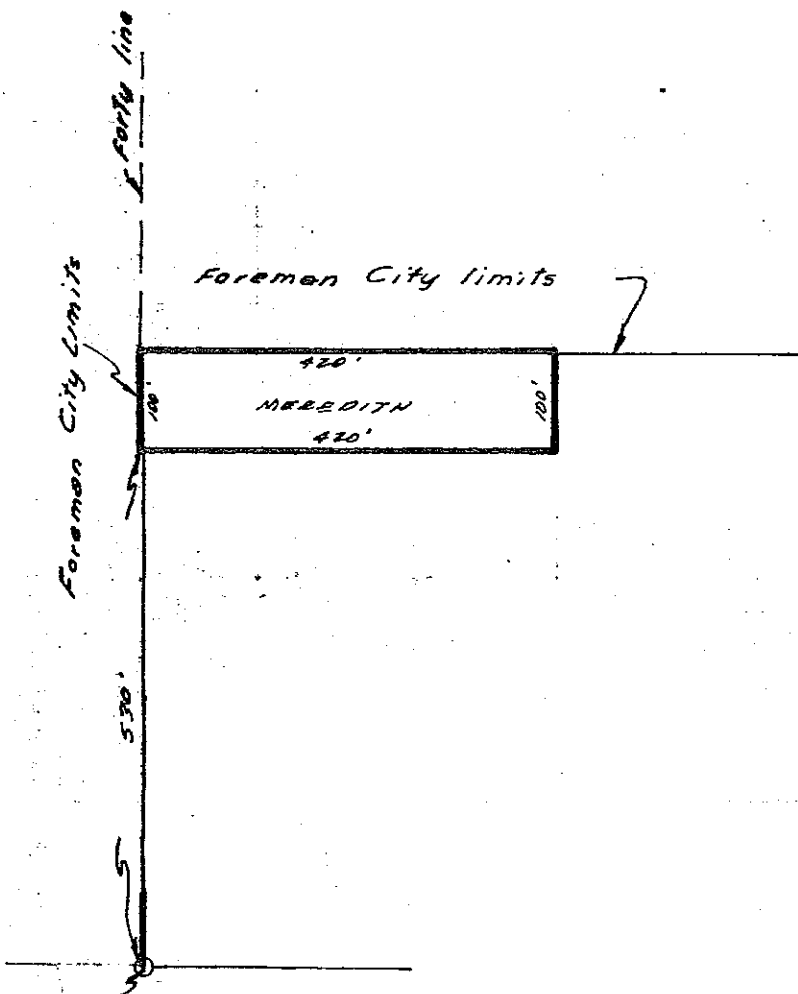

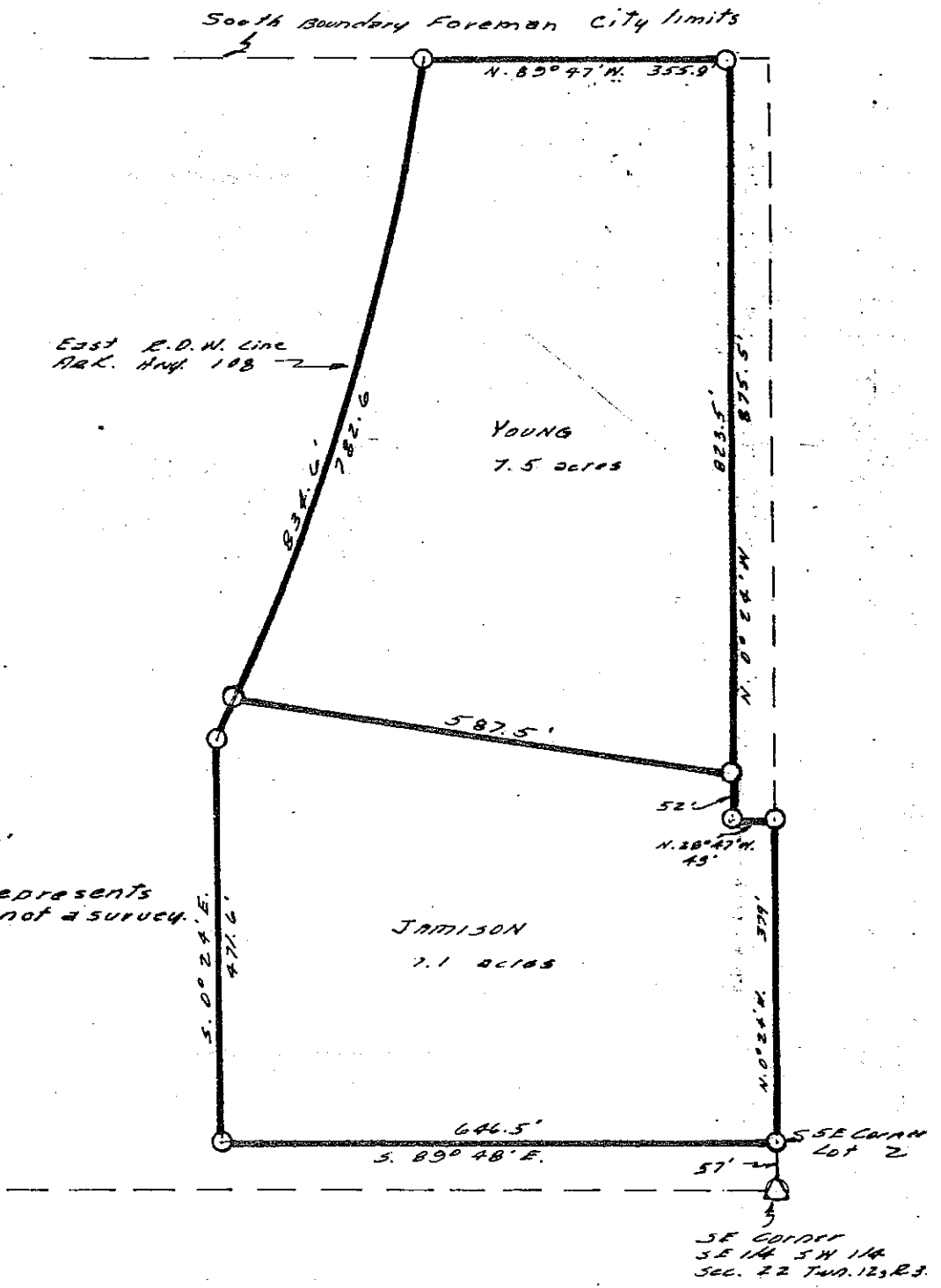

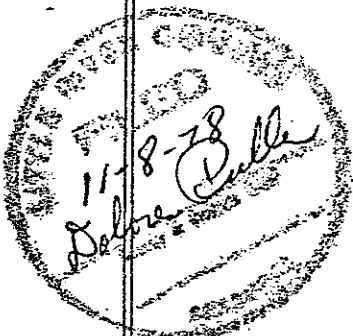
ORDER OF ANNEXATION

Now on this 8th day of November, 1978; came on for hearing, the Petition filed herein by the Petitioners in the above styled and numbered cause, the Petitioners appearing by name as set forth in the Petition filed herein, and by and through their attorney of record, Ted C. Capeheart, Attorney at Law, Ashdown, Arkansas and from the pleadings filed, allegations of the Petition, proof submitted to the Court, exhibits filed, the signatures appearing on and with said Petition, statements of counsel, and other matters, things and proof before the Court, from all of which the Court is well and sufficiently advised in the premises, and from all of which the Court finds:

1. That the requirements for signatures under Section 19-301 Ark. Stats. Ann., have been complied with in full.
2. That the limits of the territory to be annexed to the City of Foreman have been accurately described and an accurate map and plat thereof made and filed herein.
3. That the prayer of the Petitioners is right and proper.
4. That all requirements of Notice have been met by the parties seeking to annex said territory and that said Notice has been published once a week for three (3) consecutive weeks in a newspaper of general circulation in Little River County, Arkansas; said Notice containing the substance of said Petition and stating the time and place appointed for the hearing thereof.

WHEREFORE, it is CONSIDERED, ORDERED, ADJUDGED and DECREED that the herein below described property, contiguous to and adjoining the City of Foreman Arkansas; Little River County, Arkansas, the property so annexed being more particularly described as follows, to-wit:




