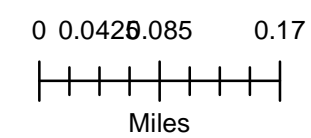

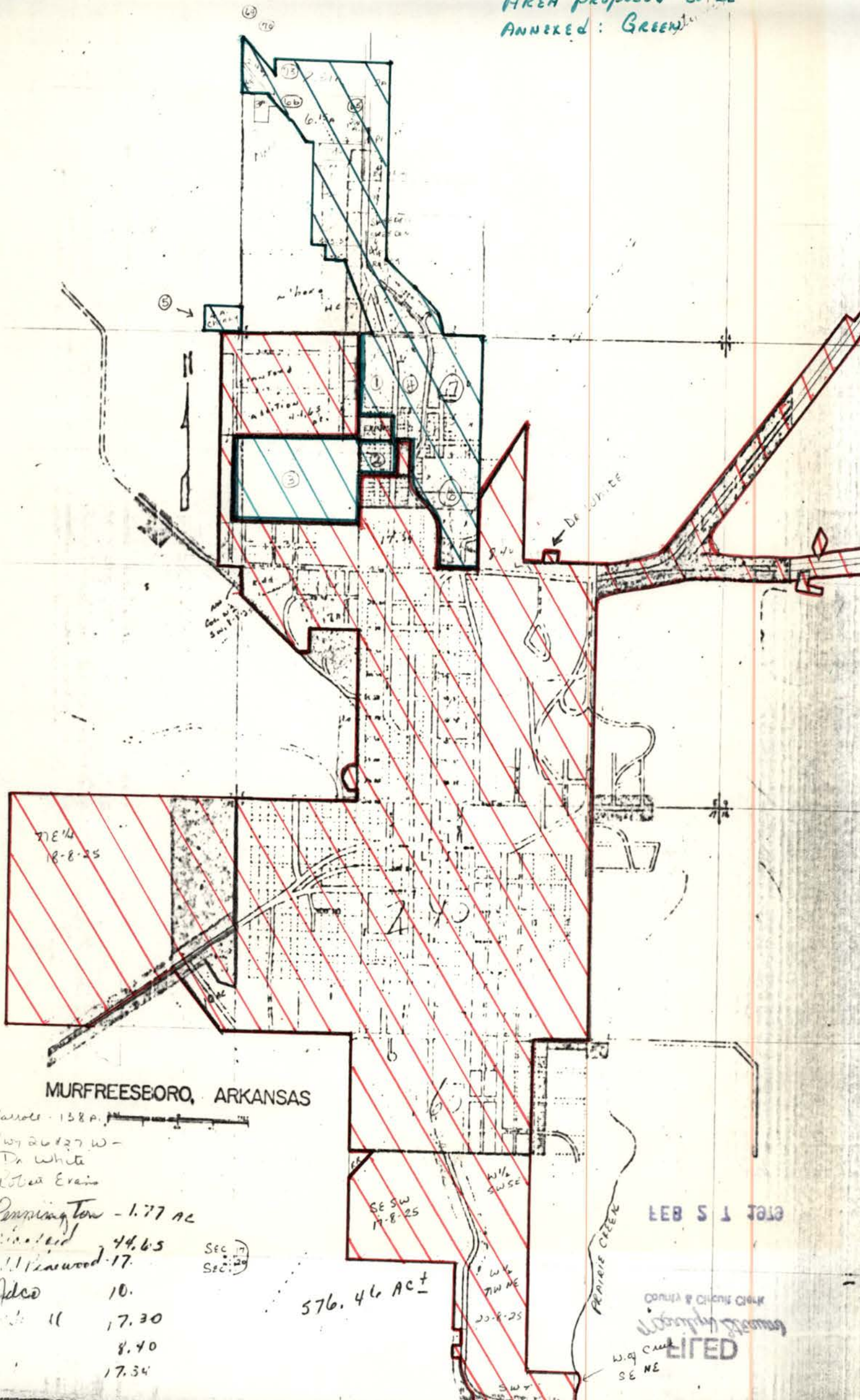



DECREE OF ANNEXATION







ORDER MODIFYING DECREE OF ANNEXATION

Now on this 27th day of November, 1979, is presented to this Court the joint petition of George E. Steel, as attorney for Melvin Price, and Jimmy L. Featherston, as attorney for the City of Murfreesboro, seeking to modify that decree of annexation made and entered by this same Court in this same cause on the 29th day of March, 1979, so as to delete, strike and remove therefrom a strip of land 200 feet in width adjoining the North boundary of right of way of Chaney Trace Road in Tracts 69 and 70, and, from said petition and other matters and proof, this court finds:

That the relief prayed for in said joint petition to modify should be granted and that the decree of annexation made and entered by this same Court in this same cause on the 29th day of March, 1979, should be modified so as to delete therefrom a strip of land 200 feet in width adjoining the North boundary of right of way of Chaney Trace Road in Tracts 69 and 70, thereby excluding said land from said order of annexation and moving said land outside the corporate limits of the City of Murfreesboro, in Pike County, Arkansas.

IT IS, THEREFORE, by this Court considered, ordered, decreed and adjudged that the decree of annexation made and entered by this same Court in this same cause should be and the same is hereby modified so as to delete, strike and remove therefrom a strip of land 200 feet in width adjoining the North boundary of right of way of Chaney Trace Road in Tracts 69 and 70, so as to exclude said lands from said order of annexation so that said lands may be and remain outside the City Limits of the City of Murfreesboro, in Pike County, Arkansas.
