ORDINANCE NO. <u>2013</u>-4

"AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED LANDS TO THE TERRITORY OF THE CITY OF LEAD HILL, BOONE COUNTY, ARKANSAS"

WHEREAS, Lead Hill School District, Holt Memorial Chapel,

Inc., Pat Hopkins Revocable Family Trust dated January 29, 1997 and Jeffrey Dell and Patricia Dell being the owners of the following described tracts in Harrison, Boone County, Arkansas,

Pursuant to Arkansas Code Section 14-40-601, to-wit

A part of the Southeast quarter of the Southeast quarter of Section 5, Township 20 North, Range 18 West, more particularly described as follows, to-wit: commencing at the SE corner of Section 5, thence West along Section line 660 feet to the place of beginning; thence North 429 feet; thence West 152.3 feet ; thence South 429 feet; thence East 152.3 feet to the point of beginning, containing 1½ acres, more or less.

AND, WHEREAS, said County Court has duly made and entered its Order dated April 8 2013, approving the annexation.



ORDINANCE NUMBER 80- /

AN ORDINANCE ANNEXING THE FOLLOWING DESCRIBED LANDS, TO-WIT: A parcel of land located in Section 8 Township 20 North, Range 18 West in Boone County, Arkansas, described as beginning at the point where the South line of Arkansas State Highway # 7 crosses the East line of Section 8, Inn thence Southwesterly along said right of way line to a point which is 660 feet west of the east line of the Southwest Quarter of the Southeast Quarter of said section, frun thence North to a point on a line which line is described as being 300 feet from and parallel to and north of the North and West boundary of said Highway # 7, thence with the said line in a northeasterly direction to the point where the same intersects the East line of Section 8, thence South on said line to the point of beginning CONTIGIOUS TO THE INCORPOR-TED TOWN OF <u>SOUTH LEAD HILL</u>, ARKANSAS, TO SAID FOWN, CALLING AN ELECTION THEREON AND FIXING THE DATE OF SAID ELECTION, PRESCRIBING A SCHED-FILF ULE OF SERVICES OF THE TOWN TO BE EXTENDED TO NOV 10 1980 THE SAID LANDS WITHIN THREE YEARS AFTER THIS ORDINANCE BECOMES FINAL, DECLARING AN EMERGENCY FR. J. RIVIERE AND FOR OTHER PURPOSES.

> WHEREAS, THE Town Council of the Incorporated Town of South Lead Hill, Arkansas finds that the above described lands are: (a) needed for the municipal purpose of extended police protectionl, (b) are held to be sold as suburban property and (c) are valuable by reason of their adaptability for prospective municipal uses;

> WHEREAS, the Town Council further finds that the highest and best use of the said lands is not for agricultural or horticultural purposes and that they are not lands upon which a new community is to be constructed with federal funds under Title IV of the Housing and Urban Development Act of 1968;

WHEREAS, the Town Council further finds that state law provides that the said lands may continue to be used for the purposes for which they are now used after annexation;

WHEREAS, the said lands should be annexed to and become a part of the Incorporated Town of South Lead Hill, Arkansas,

NOW THEREFORE, BE IT ORDAINED by the Town Council of the Incorporated Town of South Lead Hill, Arkansas, as follows:

 That the findings above set out are true and correct.
 That the lands described in the title hereof are hereby annexed to the Incorporated Town of South Lead Hill, Arkansas.
