#### **ORDER OF ANNEXATION**

Now on this 29<sup>th</sup> day of November, 1999, comes on to be heard the Petition of Larry Lingo as agent for himself and others, et al, for the annexation to the City of Altus, Arkansas, of the following described territory lying contiguous to the existing City of Altus, Arkansas, in Franklin County, Arkansas, to-wit:

Part of the N ½ of the SW ¼ and part of the W ½ of the NW ¼ of Section 09 - Township 09 North - Range 26 West lying South and West of the Centerline of U. S. Highway 64, containing approximately 54.06 Acres more or less.

Part of the SW ¼ of the SW ¼ of Section 04 - Township 09 North - Range 26 West lying South and West of U.S. Highway 64, containing approximately 2.0 Acres more or less.

Part of the NE ¼ of the SE ¼ and part of the S ½ of the NE ¼ and part of Tracts A & B of Leisure Estates Phase I and all of Tract 4 of Leisure Estates Phase II all in Section 05 - Township 09 North - Range 26 West lying South and West of the Centerline of U. S. Highway 64, containing approximately 10.1 Acres more or less.

Part of the N ½ of the NE ¼ of the SW ¼ and part of the SW ¼ of the SE ¼ less and except a 220' X 995' tract on the West side of said SW ¼ of the SE ¼ in Section 09 - Township 09 North - Range 26 West lying North and East of the Centerline of U. S. Highway 64, containing approximately 51.5 Acres more or less.

Part of the S ½ of the SW ¼ of the SW ¼ of Section 04 - Township 09 North - Range 26 West lying North and East of the Centerline of U. S. Highway 64, containing approximately 18.0 Acres more or less.

Part of the E ½ of the SE ¼ and part of the E ½ of the SE ¼ of the NE ¼ and all of Chrisman Addition Phase 1 & 2 being in the W ½ of the NE ¼ and the W ½ of the SE ¼ of the NE ¼ and part of the E ½ of the SE ¼ of the NE ¼ of Section 05 - Township 09 North - Range 26 West lying North and East of the Centerline of U. S. Highway 64, containing approximately 26.5 Acres, more or less.

Total Approximate Acreage: 162.16 Acres.

The Acreage contained inside the Highway Right-of-Way was not included in Total Approximate Acreages. Reference to Acreage is for identification purposes only. The Highway Right-of-Way varies in widths, but it is the intent to include the Right-of-Way in the proposed Annexation beginning at the existing City of Altus Boundary at the Southeast Corner of the SW ¼ of Section 09 - Township 09 North - Range 26 West extending North and West along said Right-of-Way across all previously described parcels of land, terminating at the West Line of the E ½ of the SE ¼ of the NW ¼ of Section 05 - Township 09 North - Range 26 West.


And it further appearing to the Court that there are no remonstrants or persons appearing to contest the annexation or having filed any objections to said annexation and that all of the real estate owners or a majority of them as provided by law within the above described territory lying contiguous to and adjoining the present city limits of Altus, Arkansas, have signed said Petition for annexation.

And it further appearing to the Court that the limits to the territory to be annexed to the City of Altus, Arkansas, as hereinabove set forth are accurately and fully described in said Petition and that an accurate map thereof has been made and filed with the Petition herein showing said lands to lie adjacent to the existing boundaries of the City of Altus, Arkansas. And it appearing from said Petition, other matters, things and proof, both oral and documentary, before the Court, that the allegations of the said Petition are true and that it will be in the best interest of the Petitioners and of the citizens of the City of Altus, Arkansas, that said land be annexed to and included within the boundaries of the City of Altus, Arkansas.

IT IS, THEREFORE, BY THE COURT, CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Petition for annexation filed herein be, and the lands described therein in said Petition are hereby, annexed to and made a part of the City of Altus, Arkansas, as prayed for in said Petition.

# ORDINANCE NO. 1999-9

SHARON NEEDHAM COUNTY AND PROBATE CLERK

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF ALTUS, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF ALTUS, AND ASSIGNING SAME TO WARDS.

WHEREAS, petition was filed with the County Clerk of Franklin County,
Arkansas, by the majority of the real estate owners of the hereinafter described
territory praying that said territory be annexed to, and made a part of the City of Altus,
Arkansas; and,

WHEREAS, on November 29, 1999, the County Court of Franklin County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Altus, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Altus, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALTUS, ARKANSAS:

SECTION 1. That the following described lands and territory contiguous and adjoining the City of Altus, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Altus.

Part of the N½ of the SW¼ and part of the W½ of the NW¼ of Section 09 - Township 09 North - Range 26 West lying South and West of the Centerline of U. S. Highway 64, containing approximately 54.06 Acres more or less.

Part of the SW ¼ of the SW ¼ of Section 04 - Township 09 North - Range 26 West lying South and West of U.S. Highway 64, containing approximately 2.0 Acres more or less.

Part of the NE ¼ of the SE ¼ and part of the S ½ of the NE ¼ and part of Tracts A & B of Leisure Estates Phase I and all of Tract 4 of Leisure Estates Phase II all in Section 05 - Township 09 North - Range 26 West lying South and West of the Centerline of U. S. Highway 64, containing approximately 10.1 Acres more or less.
