

Begin at a point in the center of the St. L. & S.F. R.R. track at a rightangle to the west end of the R.R. station in Section 34, Tlon, R2E, thence northwesterly along center of said R.R. track for a distance of 1,240 ft. to the point of beginning; thence southwesterly at right angles and perpendicular to said R.R. track a distance of 1,320 ft.; thence southeasterly and parallel to said R.R. track to the west bank of Cache River in the NW 1/4 of Section 2, T15N, R2E; thence north along the west bank of said river to the center of R.R. track; thence northeasterly along the west riverbank to a point that is 560 ft. at right angles and perpendicular to said St. L. & S.F.
