ORDER AUTHORIZING ANNEXATION OF LANDS TO THE CITY OF PALESTINE, ARKANSAS

Now on this date, comes Janell Hawkins Byrd, et al,
Petitioners in the above styled cause, praying for annexation of certain lands to the City of Palestine, Arkansas,
and praying that the property hereinafter described be annexed to and made a part of the City of Palestine, Arkansas,
and the matter is presented to the Court upon the original
petition, plat of the territory described, the proof of publication of the notice of filing and hearing on said petition, and evidence adduced orally before the Court, from all
of which the Court doth find:

That the petition for annexation was filed herein on August 9, 1989, and that a notice of hearing was filed herein August 9, 1989, fixing the time and place for hearing on said petition; that due notice has been given of the filing of the petition and of the time fixed for the hearing thereon in the manner and for the time prescribed by law; that no exceptions have been filed and there is no contest of the petition; that no person has appeared or appears to object or except to the granting thereof; that a majority of the number of owners of the property hereinafter described, representing a majority of the number of acres contained within the property hereinafter described, have joined in said petition asking that the said property be annexed to the City of Palestine, Arkansas; that said lands are accurately described in said petition; that an accurate map or plat thereof has been duly made and filed with the said petition; that said property described in said petition and hereinafter described, is a part of St. Francis County, Arkansas, and is contiguous to and adjoins the City of

Palestine, Arkansas; that all of the Petitioners desire that said property be annexed to and made a part of Palestine, Arkansas; that said Petitioners have, in all respects, complied with the law provided for in such cases and that the prayer of the Petitioner is right and proper and the same should be granted.

The SE 1/4 of the SW 1/4 and the E 1/2 of the SW 1/4, SW 1/4 of Section 5, T4N-R2E of the 5th P.M., St. Francis County, Arkansas, and also part of the NW 1/4 of Section 8, T4N-R2E of the 5th P.M., and being more particularly described as follows: Beginning at the NW Corner of said NW 1/4, Section 8, thence South 1190.8 feet along the West line thereof to a point 50 feet South of and parallel to the South R/W line of Interstate 40; thence N78° E 1186.1 feet along a line 50 feet South of and parallel to said South R/W line of Interstate 40 to a point; thence N69°12'54"E 615.6 feet along a line 50 feet South of and parallel to said South R/W line of Interstate 40 to a point; thence N63° 38'30"E 1140.3 feet along a line 50 feet South of and parallel to said South R/W line of Interstate 40 to a point on the East line of said NW 1/4, Section 8; thence North 275 feet along said East line of NW 1/4, Section 8 to the NE Corner thereof; thence West 2795.0 feet along the North line of said NW 1/4, Section 8 to the point of beginning.






