AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MANIEA, ARKANSAS, BEING LOCATED IN SECTION 6, TOWNSHIP 14 NORTH, RANGE 9 EAST, CHICKASAWBA DISTRICT, MISSISSIPPI COUNTY, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MANILA, AND ASSIGNING SAME TO CERTAIN WARDS, AND OTHER PURPOSES.

WHEREAS, petition was filed with the County Clerk of the Chickasawba District of Mississippi County, Arkansas, by the sole real estate owner of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Manila, Arkansas; and

WHEREAS, on September 21, 2020, the County Court of the Chickasawba District of Mississippi County, Arkansas, found that the petition was signed by the sole real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Manila, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Manila, Arkansas, subject to the acceptance of the same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

WHEREAS, it is in the best interest of the City of Manila, Arkansas, that said territory be accepted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MANILA, ARKANSAS:

SECTION 1. That the following described lands and territory contiguous and adjoining the City of Manila, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Manila, Arkansas.

EXHIBIT "A" attached hereto.

SECTION 2. That the above described territory shall be annexed to and made a part of Ward 2, of the City of Manila, Arkansas, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.




