



ORDINANCE NO. 396

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF LANDS LYING SOUTH OF THE CURRENT CITY BOUNDARY; CALLING A SPECIAL ELECTION; ASSIGNING SAID LANDS TO A WARD; LEVYING MILLAGE ON SAID LANDS AND FOR OTHER PURPOSES.

This Ordinance for Annexation is pursuant to Act 298 of 1971 (and Acts amendatory thereto) as codified in A. C. A. §14-40-301 et. seq.

The City of Clarendon proposes to annex lands in Monroe County, Arkansas lying south of the current City boundary. Said lands are more particularly described as follows:

All that part of Private Survey #2309, Township 1 North, Range 3 West, Monroe County, Arkansas lying south of the current City of Clarendon boundary line and east of the west bank of the White River, <u>less and</u> <u>except</u> the east 1600.7 feet of said Private Survey #2309,

and;

The fractional Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section 27, Township 1 North, Range 3 West,

and;

The fractional Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section 27, Township 1 North, Range 3 West,

and;

That part of the Northwest Quarter (NW 1/4) of the Northwest Quarter (NW 1/4) of Section 27, Township 1 North, Range 3 West lying east of the west bank of the White River.

A plat of said lands will be on file with the City Clerk within 5 working days of the passage of this ordinance and may be inspected in her office during regular business hours.

That the City Council of the City of Clarendon finds that said lands are needed for a proper municipal purpose such as the extension of needed police regulation and are valuable by reason of their adaptability for prospective municipal uses. It is hereby found that said lands should be annexed to the City limits of the City of Clarendon, Arkansas and become part of the City of Clarendon, Arkansas. Within three (3) years of the date the annexation shall become final, the City of Clarendon will extend the following services to the area to be annexed:

Fire protection Police protection Garbage collection Water and sewer service Development of parks and recreational facilities. 16

When annexed, the area described herein shall become part of Wards 1 & 2 of the City of Clarendon.

That upon said annexation becoming final, the millage that applies to the City of Clarendon shall be levied upon the annexed area.

In accordance with A. C. A. \$14-40-303(a)(3), a special election should be called for <u>Tuesday</u>, <u>December 12</u>, 1995, to present to all qualified electors the question of this annexation.

BE IT, THEREFORE, ORDAINED that the above described lands be annexed to and become part of the City of Clarendon, Arkansas; that when annexed, said lands shall become part of Wards 1 & 2of said City; that upon said annexation becoming final, the millage levied by the City of Clarendon shall be levied upon said lands annexed; that a special election be and is hereby called for <u>Tuesday</u>, <u>December 12</u>, 1995, to present to the qualified electors this question of annexation.

This Ordinance for Annexation having been passed and approved by the City Council of the City of Clarendon this 5th day of September, 1995, by a vote of 4 to 0, the same is hereby adopted by the City Council of the City of Clarendon.
