

IN THE PHILLIPS COUNTY COURT

ORDER

Now on this the _____day of March, 1964, being a regular day of the Phillips County Court, upon the petition for annexation of certain territory to the City of West Helena, Phillips County, Arkansas, heretofore filed on the 2 day of 46, by a majority of the owners thereof, and upon the Order of this court dated February 3, 1964, fixing the time and place of a hearing of all interested parties for or against the annexation of said territory to be heard on March 2, 1964, at 10:00 A.M., and upon the proof of publication of the Notice of the time and place of said hearing by the Helena World Publishing Company, a newspaper having a legal and bona fide circulation in Phillips County, Arkansas, and the court being well and sufficiently advised, and, after having been heard all of the persons interested in the question of annexation of said area, doth hereby find that the property is contiguous and adjoining the City of West Helena, Phillips County, Arkansas, and that it would be to the best interest of all parties concerned that it be incorporated into and made a part of the City of West Helena, Phillips County, Arkansas, and the court doth, therefore, grant the said petition.

Now, therefore, it is CONSIDERED, ORDERED AND ADJUDGED that the following described property be and is hereby incorporated into and made a part of the City of West Helena, Phillips County, Arkansas, to-wit:

Commencing at the Southwest corner of the Southwest Quarter (SWg) of Section 36, Township 1 South, Range 4 East, Phillips County, Arkansas, and running thence North 17.92 chains; thence East 17.62 chains to the middle of the Public road known as "Mil Road"; thence South 7° 20' East along sall road 5.61 chains; thence West 9.11 chains; thence South 12.35 chains to the South line of said Section 36; thence West 9.22 chains to the point of beginning.
