### **RESOLUTION NO. R-19-02**

A RESOLUTION ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF ARKADELPHIA, APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA; AND ASSIGNING SUCH WARDS.

WHEREAS, a petition was filed, pursuant to A.C.A. 14-40-609, for the annexation of certain territory into the city of Arkadelphia, Arkansas; and

WHEREAS, the Clark County Assessor and the Clark County Clerk have

- (A) Verified the identity of the petitioner(s);
- (B) Verified that there are no property owners included in the petition that do not wish to have their property annexed;
- (C) Verified that the property or properties are contiguous with the City of Arkadelphia;
- (D) Verified that no enclaves will be created if the petition is accepted by the City of Arkadelphia; and presented the petition and their respective verifications to the Clark County Judge; and

WHEREAS, the County Judge has

- (A) Reviewed the petition and verifications to the for completeness and accuracy;
- (B) Determined that no enclaves will be created by the annexation;
- (C) Confirmed that the petition contains a schedule of services;
- (D) Found that the land to be annexed does not meet any of the disqualifying factors under A.C.A. 14-40-302.
- (E) Issued an order articulation these findings and forwarded the petition and order to the contiguous City of Arkadelphia for consideration; and

WHEREAS, it is the desire of the City of Arkadelphia that said territory be annexed.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF ARKADELPHIA, ARKANSAS THAT:

Section 1. That the following described territory, contiguous to the City of Arkadelphia, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Arkadelphia, Arkansas:

Section 2. That the following schedule of services shall extend to the area by the City of Arkadelphia within the statutory required three (3) year period after the date the annexation becomes final, as follows:

Water, Police, Sanitation, and Fire services.

- Section 3. That the above described territory shall be annexed to and made a part of Ward 5 of the City of Arkadelphia, and the same shall henceforth be a part of said Ward as fully as existing parts of said Ward.
- Section 4. Thirty (30) days after passage and publication or posting of this Resolution as authorized by law, the annexation shall be final and the property shall be with in the corporate limits of the City of Arkadelphia, except as otherwise ordered by the Circuit Court pursuant to a cause of action filed within said thirty (30) day period.
- Section 5. Notice. Within forty-five (45) days of the effective date of this Resolution the City Clerk shall provide written notice, along with complete documentation, to the County Clerk of each county in which the territory is affected.




