

*Saline County # 97-1*ORDINANCE 97-6 OF 1997

AN ORDINANCE TO SUBMIT TO THE VOTERS OF THE CITY OF BAUXITE, ARKANSAS, AND OTHER AFFECTED PERSONS, THE QUESTION OF ANNEXATION TO SAID CITY OF BAUXITE, ARKANSAS CERTAIN CONTIGUOUS TERRITORY

WHEREAS, it appears to the City Council of the City of Bauxite, Arkansas, that certain hereinafter described territory contiguous to the City of Bauxite is necessary for the orderly growth of said City, and

WHEREAS, the lands furnish abode for a densely settled community or represent the actual growth of the municipality beyond its legal boundary.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAUXITE, ARKANSAS:

Section 1. That there shall be submitted to the qualified electors of the City of Bauxite and of the following described area:

<u>Parcel No.</u>	<u>Legal description</u>
1.	The Southeast Quarter and the East half of the Southwest Quarter of Section 8 except that part already incorporated as the town of Bauxite on August 14, 1972.
2.	The Northeast Quarter and the East half of the Northwest Quarter of Section 17 except that part already incorporated as the town of Bauxite on August 14, 1972.
3.	The West Half of the Southwest Quarter of the Southwest Quarter and the North half of the East half of the Southwest Quarter of the Southwest Quarter of Section 9.
4.	The North half of the West half of the Southeast Quarter of the Southwest Quarter and the East half of the Southeast Quarter of the Southwest Quarter of Section 9.
5.	The Northeast Quarter of the Northwest Quarter, the Northwest Quarter of the Northeast Quarter, the Southwest Quarter of the Northeast Quarter of the Northeast Quarter, and the Southeast Quarter of the Northeast Quarter of Section 16.
6.	The Southwest Quarter of the Southeast Quarter, the Southeast Quarter of the Southeast Quarter, and the Northeast Quarter of the Southeast Quarter of

the 8 day of April, 1997. The City Clerk shall immediately notify the County Election Commission by forwarding a certified copy of this ordinance.

Section 3. If at such election a majority of the qualified electors voting in such election shall vote for such annexation the municipality shall proceed to file a description and a map of the annexed area with the County Clerk of the county wherein the land lies and with the Secretary of State. The annexation shall be included within the corporate limits of the annexing city thirty (30) days following the filing of the description and map with the County Clerk, or in the event an action is filed with the Circuit Court on the date the judgement of said Court becomes final. If a majority of the qualified electors voting on the issue at the election vote against the annexation, the annexation ordinance shall be null and void.

Section 4. If the annexation is approved and becomes final, the following services shall be extended to the area within three (3) years:

Section 5. The ballots used at said election on the question of annexation shall be marked as follows:

Section 6. An emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage.

16. The Northwest Quarter of the Northwest Quarter and the West half of the Northeast Quarter of the Northwest Quarter of Section 14.
17. The East half of the Northeast Quarter of the Northeast Quarter of Section 15.
