ARKANSAS, AND OTHER AFFECTED PERSONS, THE QUESTION OF
ANNEXATION TO SAID TOWN OF BAUXITE, ARKANSAS CERTAIN
CONTIGUOUS TERRITORY**

WHEREAS, it appears to the Town Council of the Town of Bauxite, Arkansas, that certain hereinafter described territory contiguous to the Town of Bauxite is necessary for the orderly growth of said Town.

WHEREAS, West Sardis road, begining at the end of the 1997 Bauxite annexation- to the beginning of the 2007 Bauxite annexation of West Sardis road and parcels: 001-05368-000, 001-05368-002, 001-05368-001, 001-05365-000.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAUXITE, ARKANSAS:

SECTION 1. That there shall be submitted to the qualified electors of the Town of Bauxite and the following described area:

That part of the North Half of the Southwest Quarter of Section 11 township 2 South, Range 14 West of the Fifth Principle Meridian, Saline County, Arkansas, including West Sardis Road and including but not exclusive to following Saline County Arkansas parcels 001-05368-000, 001-05368-002, 001-05368-001, 001-05365-000.

Described as follows:

All that part of the North Half of the Southwest Quarter of said Section 11 lying South of the North Right of Way of West Sardis Road except that part already incorporated as the Town Bauxiite, Arkansas and containing 24

acres, more or less.

SECTION 2. The question of annexation of the territory described above in Section 1 shall be submitted to the electors qualified to vote on this issue in the general election on the 8th day of November, 2016. The City Clerk shall immediately notify the County Election Commission by forwarding a certified copy of this ordinance.

SECTION 3. If at such election a majority of the qualified electors voting in such election shall vote for such annexation the municipality shall proceed to file description and a map of the annexed area with the County Clerk of the county wherein the land lies and with the Secretary of State. The annexation shall be included within the corporate limits of the annexing city thirty days following the filing of the description and a map with the County Clerk, or in the event an action is filed with Circuit majority of the qualified electors voting on the issue at the election vote against the annexation, the annexation ordinance shall be null and void.

SECTION 4. If the annexation is approved and becomes final, the following services shall be extended to the area within three years

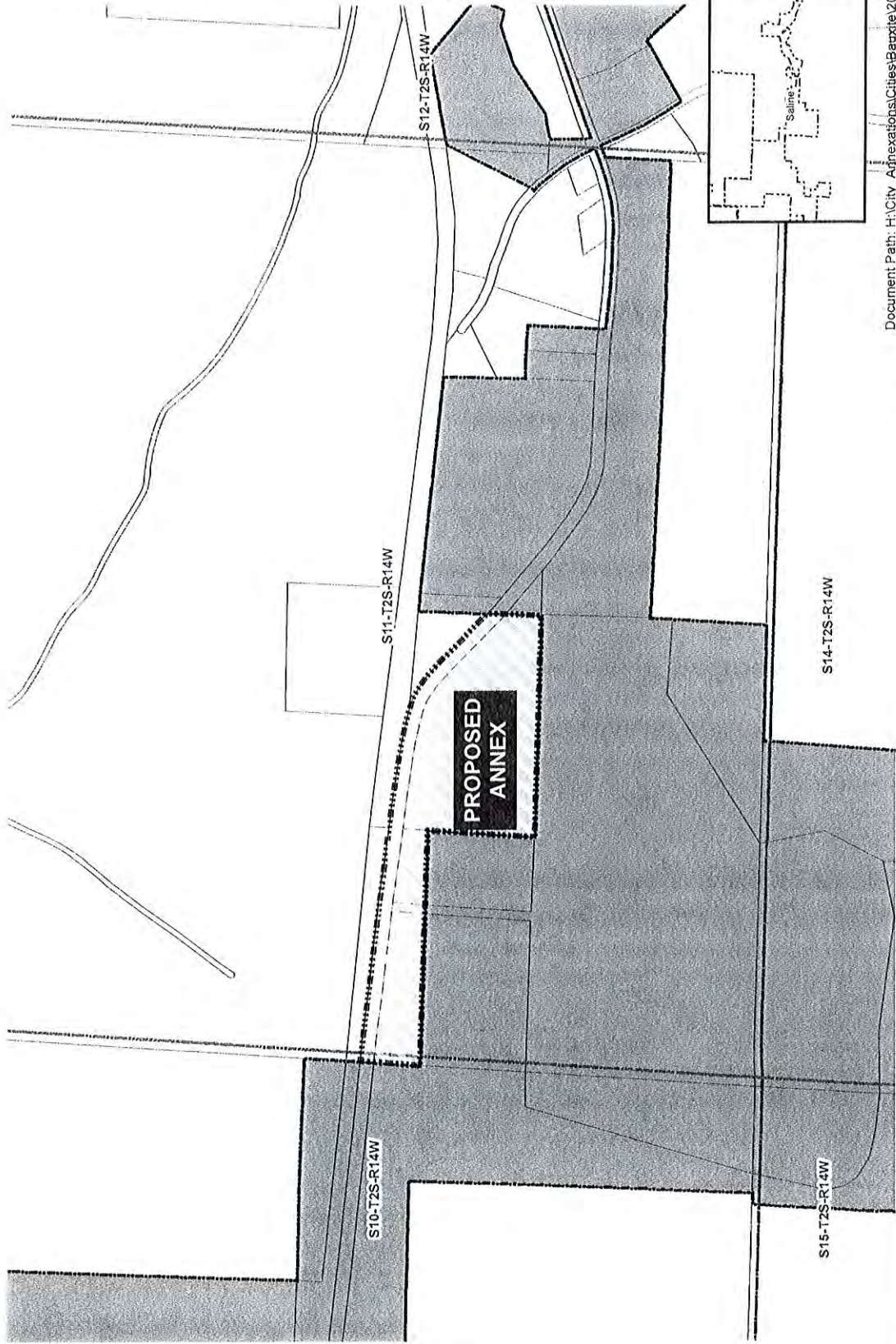
