AN ORDINANCE AMENDING ORDINANCE 56 OF 2016; CORRECTING THE LEGAL DESCRIPTION OF PROPERTY WHICH WAS ANNEXED INTO THE CORPORATE LIMITS OF THE CITY OF BENTON, SALINE COUNTY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the City Council in Ordinance 56 of 2016 annexed certain property into the corporate limits of the City of Benton, Arkansas which belonged to Fred Swaim and Edith Mae Swaim Trustees of the Fred Swaim and Edith Mae Swaim Joint Revocable Trust; and

WHEREAS, the City Council has been advised that the legal description which was provided to the City had errors within it which have since been corrected; and

WHEREAS, the County Court of Saline County on or about May 11, 2017 entered an Amended and Supplemental Order authorizing the annexation and correcting the legal description; and
