#### ORDER OF ANNEXATION

On the 1774 day of October, 2000, comes on for hearing before the Court the petition for annexation of certain lands to the City of Caraway, Arkansas, filed in this Court on September 5, 2000. The cause is heard upon the petition, notice of filing of said petition and of the date, time and place of hearing thereon, and the proof of publication of such notice as required by law, and the evidence introduced by witnesses, and all other matters and things before the Court, from all of which the Court finds:

- 1. That the petition filed herein is signed by the owner of all of the real estate requesting to be annexed.
- 2. That the limits of the territory to be annexed have been accurately described and an accurate map thereof made and filed herein.
- 3. That the notice of the filing of said petition and the date, time and place of this hearing upon said petition has been duly given and published as required by law.

4. That all things required by law to be done have been duly and properly done, and the allegations of the petition are sustained by proof.

It is therefore by the Court CONSIDERED AND ORDERED that the petition herein be, and it is hereby granted, and all of the lands and territory herein described be, and they are hereby annexed to the City of Caraway, Arkansas, said lands and territory so annexed to the City of Caraway, Arkansas being more particularly described as follows:

Part of the Northwest Quarter of Section 14, Township 13 North, Range 7 East, Craighead County, Arkansas being more particularly described as follows: Begin at the Northwest corner of Section 14, Township 13 North, Range 7 East, Craighead County, Arkansas; thence South 88°40'43" East along the North line of Section 14, aforesaid 1930.18 feet; thence South 0°01'04" East 1000.27 feet to the existing city limits line which is the point of beginning proper; thence continue South 0°01'04" East 272.82 feet; thence North 87°57'19" West 1430.98 feet to the existing city limits line; thence North along the existing city limits line 254.74 feet; thence South 88°40'43" East 1430.36 feet along the existing city limits line to the point of beginning proper, containing 8.66 acres.

Be it further ORDERED that said lands and territory shall be deemed and taken to be a part of the limits of the City of Caraway, Arkansas, and the inhabitants residing therein shall have and enjoy all of the rights and privileges of the inhabitants within the original limits of the City of Caraway, Arkansas, upon said lands and territory being accepted by ordinance of the City Council of the City of Caraway, Arkansas.
