AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY BELONGING TO LIFEPOINT BAPTIST CHURCH TO THE CITY OF CENTERTON; APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA; ASSIGNING SUCH TO WARDS; AND DESIGNATION OF ZONING.

WHEREAS, a petition was filed, pursuant to A.C.A. 14-40-609, for the annexation of certain territory into the City of Centerton, Arkansas; and

WHEREAS, the Benton County Assessor and the Benton County Clerk have (A) Verified the identity of the petitioner(s); (B) Verified that there are no property owners included in the petition that do not wish to have their property annexed; (C) Verified that the property or properties are contiguous with the city; (D) Verified that no enclaves will be created if the petition is accepted by the city; and presented the petition and their respective verifications to the Benton County Judge; and

WHEREAS, the County Judge has (A) Reviewed the petition and verifications for completeness and accuracy; (B) Determined that no enclaves will be created by the annexation; (C) Confirmed that the petition contains a schedule of services; and (D) Issued an order articulating these findings, and forwarded the petition and order to the contiguous City of Centerton for consideration; and

WHEREAS, it is the desire of the Mayor and City Council of Centerton that said territory be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CENTERTON, ARKANSAS:

SECTION 1. That the following described territory, contiguous to the City of Centerton, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Centerton, Arkansas to wit:

Part of the NE ¼ of the NE ¼ of Section 29, Township 20 North, Range 31 West, Benton County, Arkansas, more particularly described as follows:

Beginning at the NE corner of the NE ¼ of the NE ¼ of said S29, a mag nail; thence along the East line of said NE ¼ of the NE ¼ and the center of Gamble Road, S02°23'32"W 330.00 feet to a set mag nail; thence leaving the center of Gamble Road, N87°29'46"W 663.34 feet to a set iron pin; thence N02°16'50"E 330.00 feet to a set iron pin in the center of Herbaugh Road; thence along the North line of the said NE ¼ of the

NE ¼ and the center of Herbaugh Road, S87°29'46"E 663.99 feet back to HERPARE CLERK containing 5.03 acres, more or less.

<u>SECTION 2.</u> That the following schedule of services shall be extended to the area by the City of Centerton within the statutorily required three (3) years after the date the annexation becomes final, as follows: Police Protection – Immediately; Fire Protection – Immediately; Solid Waste Collection – Immediately; Public Street Maintenance – Immediately; and Zoning and Code Enforcement – Immediately.

SECTION 3: A map of said described lands are attached and made a part of this ordinance as Exhibit "A".

SECTION 4. That the above described territory shall be annexed to and made a part of Ward _1_ of the City of Centerton, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.


SECTION 5. That the above-described property is hereby zoned as <u>Agricultural (A-1)</u>.
