ORDER

On this 3rd day of March, 1972, comes on to be heard the Petition of Mack R. Keedy and Julia Keedy, and others, property owners, praying for the annexation of the following described lands:

Part of the Southwest Quarter of the Southwest Quarter of Section 30, Township 14 North, Range 2 East, more particularly described as follows: Beginning at the Southwest Corner of Section 30 aforesaid; thence North 53 Degrees 34 Minutes East 173.2 feet; thence North 31 Degrees 07 Minutes East 217.7 feet; thence North 28 Degrees 27 Minutes East 743.2 feet; thence North 06 Degrees 44 Minutes East 89.2 feet; thence North 11 Degrees 06 Minutes West 113.5 feet; thence North 04 Degrees 56 Minutes East 227.4 feet; thence South 84 Degrees 45 Minutes East 922.0 feet; thence South 02 Degrees 06 Minutes West 1323.5 feet; thence North 33 Degrees 46 Minutes 30 Seconds West 1480 Feet to the point of beginning;

to the Town of Cash, Craighead County, Arkansas.

From the evidence adduced, the Court finds that the above described property is contiguous to and adjoins the Town Limits of Cash, Arkansas; the petitioners are the sole and only owners of real estate located within the above described property; notice of the time, place and date of this hearing has been published once a week for three consecutive weeks in the Jonesboro Sun, a newspaper of general circulation in Craighead County, Arkansas, the first publication thereof being more than thirty days before this hearing and the petition herein has been filed for not less than thirty days.

The Court finds that the statements of the petition are true, that the territory sought to be annexed has been accurately described, an accurate map of the lands has been made and filed, and that the lands described above should be annexed and that no objections have been made to said annexation.

IT IS, THEREFORE, CONSIDERED, ORDERED AND ADJUDGED that the prayer of the petitioners is hereby granted and that the above described lands are hereby annexed to and made a part of the Town of Cash, Arkansas in Craighead County, Arkansas.

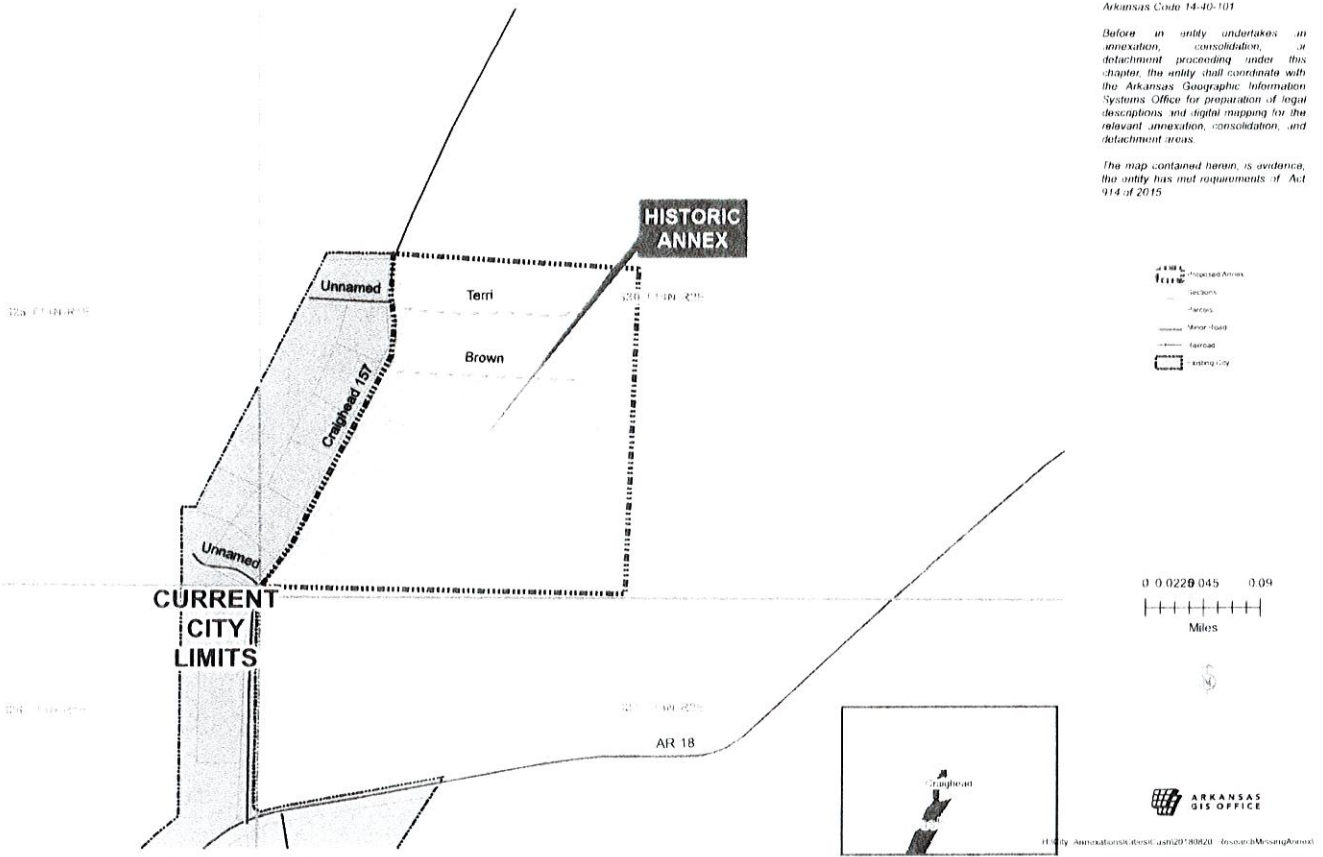
