CITY OF CENTERTON ORDINANCE NO. 2021-10

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY BELONGING TO THE PATSY WHITE REVOCABLE TRUST TO THE CITY OF CENTERTON; APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA; ASSIGNING SUCH AREA TO WARD 1; AND ZONING AS AGRICULTURAL (A-1).

WHEREAS, a Petition was filed on January 20, 2021 in the County Court of Benton County, Arkansas; pursuant to Arkansas Code Annotated section 14-40-609, County Court Case No. CC2021-05, for the annexation of certain territory belonging to the Patsy White Revocable Trust as current owner; hereinafter described, lying adjacent and contiguous to the City of Centerton, Arkansas, be annexed to, and made a part of the City of Centerton, Arkansas; and,

WHEREAS, the Benton County Assessor and the Benton County Clerk have verified that the petition: (A) is in writing; (B) contains an attestation signed before a notary by the property owner of the relevant property confirming the desire to be annexed; (C) contains an accurate description of the relevant property; (D) contains a letter or title opinion from a certified abstractor or title company verifying that the petitioner is the owner of record of the relevant property; (E) contains a letter or verification from a certified surveyor or engineer verifying that the relevant property is contiguous with the annexing city and that no enclaves will be created if the property or properties are accepted by the city; and (F) includes a schedule of services of the annexing city that will be extended to the area within three (3) years after the date the annexation becomes final; and presented the petition and records of the matter to the Benton County Judge; and

WHEREAS, on February 1, 2021, the Benton County Judge has (A) reviewed the petition and verifications for completeness and accuracy; (B) determined that no enclaves will be created by the annexation; (C) confirmed that the petition contains a schedule of services; (D) found that the land to be annexed complies with the standards for lands qualifying for annexation as set forth in A.C.A. 14-40-302(b) and (E) issued an order articulating these findings and forwarded the petition and order to the contiguous City of Centerton for consideration; and

WHEREAS, it is the desire of the Mayor and City Council of Centerton that said territory be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CENTERTON, ARKANSAS:

Page 2

Section 1: That the following described territory, contiguous to the City of Centerton, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Centerton, Arkansas to wit: Part of the SE/4 of S 36 T20N R 32W, Benton County, Arkansas, Described as beginning at a point 660 feet S 00°43'11" E of the NE corner of the SE/4 of said Section 36; thence S 00°43'11" E 990 feet; thence S 89°38'48" W 1760 feet; thence N 00°43'11" W 990 feet; thence N 89°38'48" E 1760 feet to the point of beginning, including all adjacent Right-Of-Way on the North and East sides.

Section 2: A map of said described lands is attached and made a part of this ordinance as Exhibit "A".

Section 3: That the above-described territory shall be annexed to and made a part of <u>Ward 1</u> of the City of Centerton, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 4: That the above-described property is hereby zoned as Agricultural (A-1).

Section 5: That the following schedule of services shall be extended to the area by the City of Centerton within the statutorily required three (3) year period after the date the annexation becomes final, as follows:

- A. Fire Immediately
- B. Police Immediately
- C. Water Immediately
- D. Trash Immediately

Section 6: The annexation shall be final as of the date of acceptance and approval of this ordinance and the property shall be within the corporate limits of the City of Centerton, except as otherwise ordered by the Circuit Court pursuant to a cause of action filed within a thirty (30) day period after approval of this ordinance.






