ORDINANCE NO. 2003 - CHEREUND

## AN ORDINANCE TO AMEND ORDINANCE NO. 00-283 TO CORRECT A LEGAL DESCRIPTION OF ANNEXED PROPERTY; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES

WHEREAS, the City of Clinton, pursuant to Ordinance No. 00-283 annexed certain property into the City after approval of such by the County Court; and

WHEREAS, the legal description contained in Ordinance 00-283 has been determined to be in error; and

WHEREAS, the City of Clinton and the citizens who are owners of the affected property wish to correct the description; and

WHEREAS, a correct legal description of the boundaries of the City of Clinton is essential to provide city services;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLINTON, ARKANSAS:

Section 1. The legal descriptions contained in Ordinance 00-283 is amended to read as follows:

Part of SW ¼ SW ¼ Section 1, and part of SE ¼ SE ¼ Section 2, T-10-N, R-14-W, more particularly described as: Starting at the common corner to Sections 1, 2, 11 and 12, T-10-N, R-14-W: thence N 00°03' W 297.61 feet along the line between Sections 1 and 2 to the point of beginning of the lands herein described: thence N 88°20' W 240.78 feet to a point: thence N 01°40' E 451.10 feet to a point: thence S 66°30' E 247.79 feet to a point on aforesaid Section line, said point being N 00°03' W 359.30 feet from aforesaid point of beginning, and being S 00°03' E 648.79 feet from the NW corner SW ¼ SW ¼, said Section 1: thence continuing S 66°30' E a distance of 188.10 feet to a point on the centerline of a power line: thence S 23°41' E 320.00 feet along said centerline to a point: thence N 88°20' W 300.85 feet to the point of beginning, being 74,480 square feet or 1.71 acres in SW ¼ SW ¼ Section 1, 95,140 square feet or 2.18 acres in SE ¼ SE ¼ Section 2, and containing an aggregate of 169,620 square feet or 3.89 acres, subject to a 50 foot power line easement along the easterly side thereof.
