AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF De QUEEN, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF DE QUEEN, AND ASSIGNING SAME TO WARDS.

WHEREAS, a Petition was filed with the County Clerk of Sevier County, Arkansas, by the sole real estate owner of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of De Queen, Arkansas; and,

WHEREAS, on the 12th day of January, 2016, the County Court of Sevier County, Arkansas, found that the Petition was signed by the sole real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of De Queen. Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of De Queen, Arkansas. subject to the acceptance of same by the City Council of De Queen at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said Order. Now, therefore, be it ordained by the City Council of the City of De Queen, Arkansas:

Section 1. That the following described lands and territory contiguous and adjoining the City of De Queen, Arkansas, be and the same is hereby accepted as part of and annexed to and made part of the City of De Queen, Arkansas:

A PART OF THE 5½ OF THE SW¼ OF THE SW¼ OF SECTION 21, TOWNSHIP 8 SOUTH, RANGE 31 WEST. SEVIER COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE SE CORNER OF THE E½ SW¼ SW¼ OF SAID SECTION 21; THENCE S89°51'43"W 659.17 FEET TO THE SW CORNER OF SAID E½ SW¼ SW¼; THENCE N0°07'18"W 792.64 FEET ALONG THE WEST LINE OF SAID E½: THENCE N89°51'43"E 659.76 FEET TO THE EAST LINE OF SAID E½; THENCE S0°04'45"E 792.64 FEET ALONG SAID EAST LINE TO THE POINT OF BEGINNING.
