

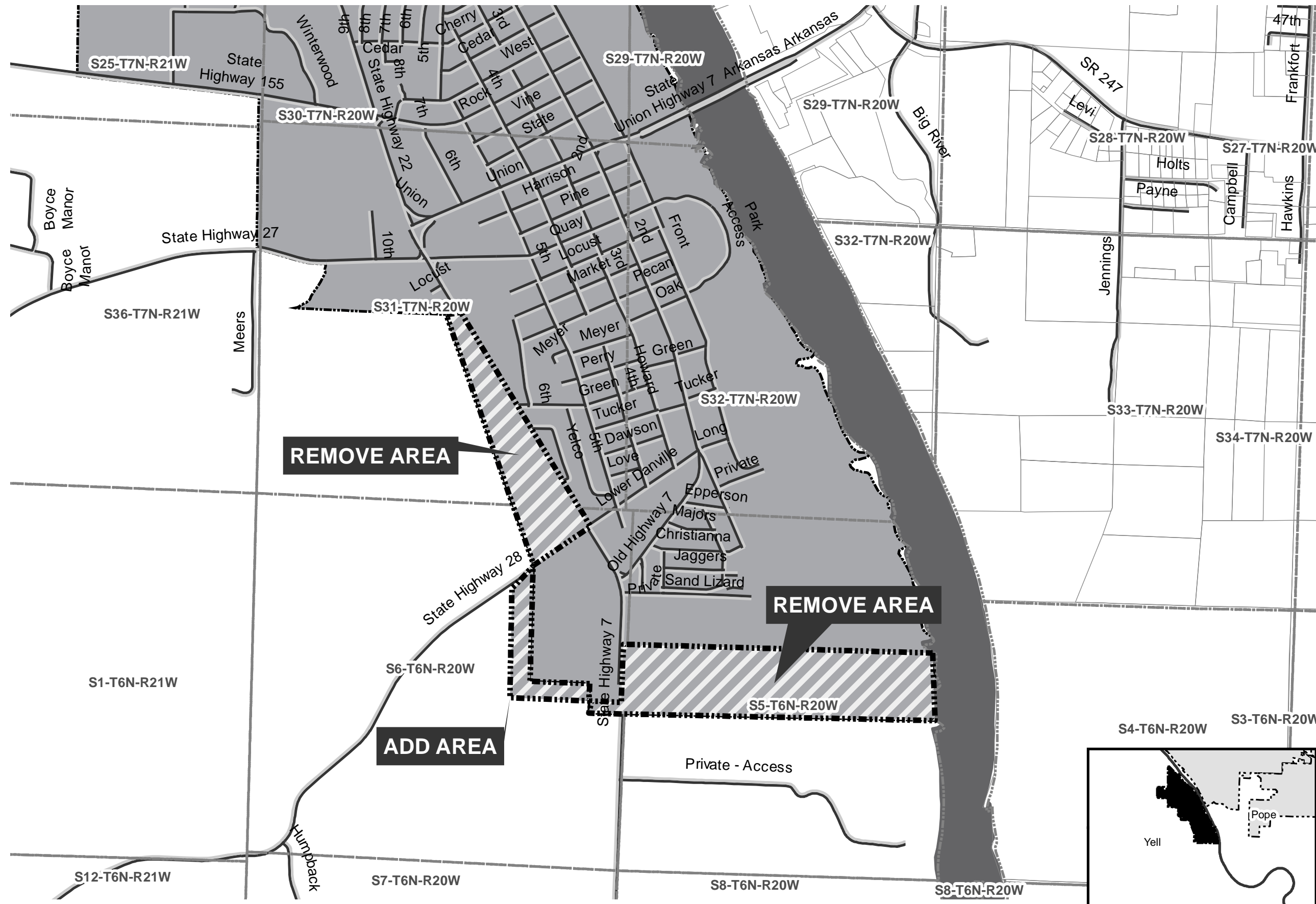

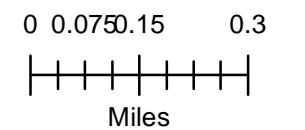

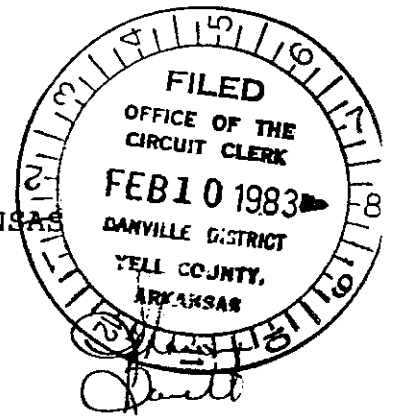

ORDER OF ANNEXATION

Now on this 10th day of February 1983, comes on for hearing and is presented to the court, the petition for annexation of Ray Lee Robinson and others, praying that the following described lands be annexed and made a part of the city of Dardanelle, Yell County, Arkansas, to-wit:

A part of the SE 1/4 of the NE 1/4 of Section 6, Township 6 North, Range 20 West, more particularly described as follows: Commencing at the Northeast Corner of said SE 1/4 of the NE 1/4, thence West 61.30 feet to a point on the West right of way of State Highway No. 7 and the point of beginning; thence beginning South .05 degrees 49' 00" East, along said right of way, along a curve to the right having a radius of 909.90 feet, a curve length of 160.85 feet, thence East along said right of way 5.00 feet, thence South along said right of way 483.50 feet, thence West 401.00 feet, thence North 322.50 feet, thence East 120.00 feet, thence North 321.00 feet, thence East 259.70 feet to the point of beginning, containing 5.00 acres, more or less.


And after a hearing thereon, together with the map and plat filed, the notice of hearing and proof of publication of same as required by law, together with other matters and things before the court, the court doth find:

That the petitioners executing said petition are the owners of all of said lands and acreage, which is contiguous to and adjoining the corporate limits to the City of Dardanelle, Arkansas, and is in Yell County, Arkansas; that the lands proposed to be annexed are accurately described; that the accurate map and plat of said territory, showing its relationship to the present city of Dardanelle, has been filed with and made a part of said Petition; that an order of this court was made and entered on the 11th day of January 1983, that a hearing on said petition be held by this court on the 10th day of February 1983 at 10:00 o'clock A.M., and petitioners were directed to give the

notice of such hearing by publication as required by law; that proper notice of the filing of said petition and this hearing has been given for the time and in the way and manner as required by law; and proper proof of publication of same by the three consecutive weekly publications in the Dardanelle Post Dispatch, a newspaper with general circulation in the City of Dardanelle and Yell County, Arkansas, and in said territory effected has been filed herein; that Kenneth M. Parsley has been appointed agent to represent said petitioners in this matter; that no objections or exceptions have been filed against said annexation; that said territory and lands should be annexed to and made a part of the City of Dardanelle, Arkansas; that the prayer of the petition is right and proper and said petition should be granted.

IT IS THEREFORE, by the court, CONSIDERED, ORDERED and ADJUDGED that the hereinabove described territory and real property, be and the same is hereby annexed to and is made a part of the city of Dardanelle, Yell County, Arkansas.

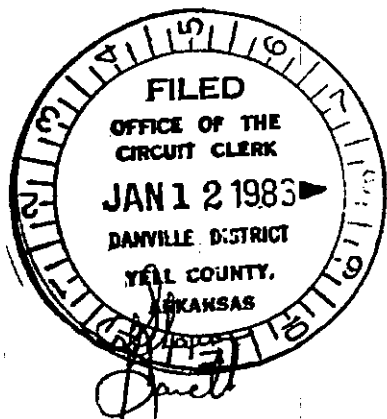

ORDER

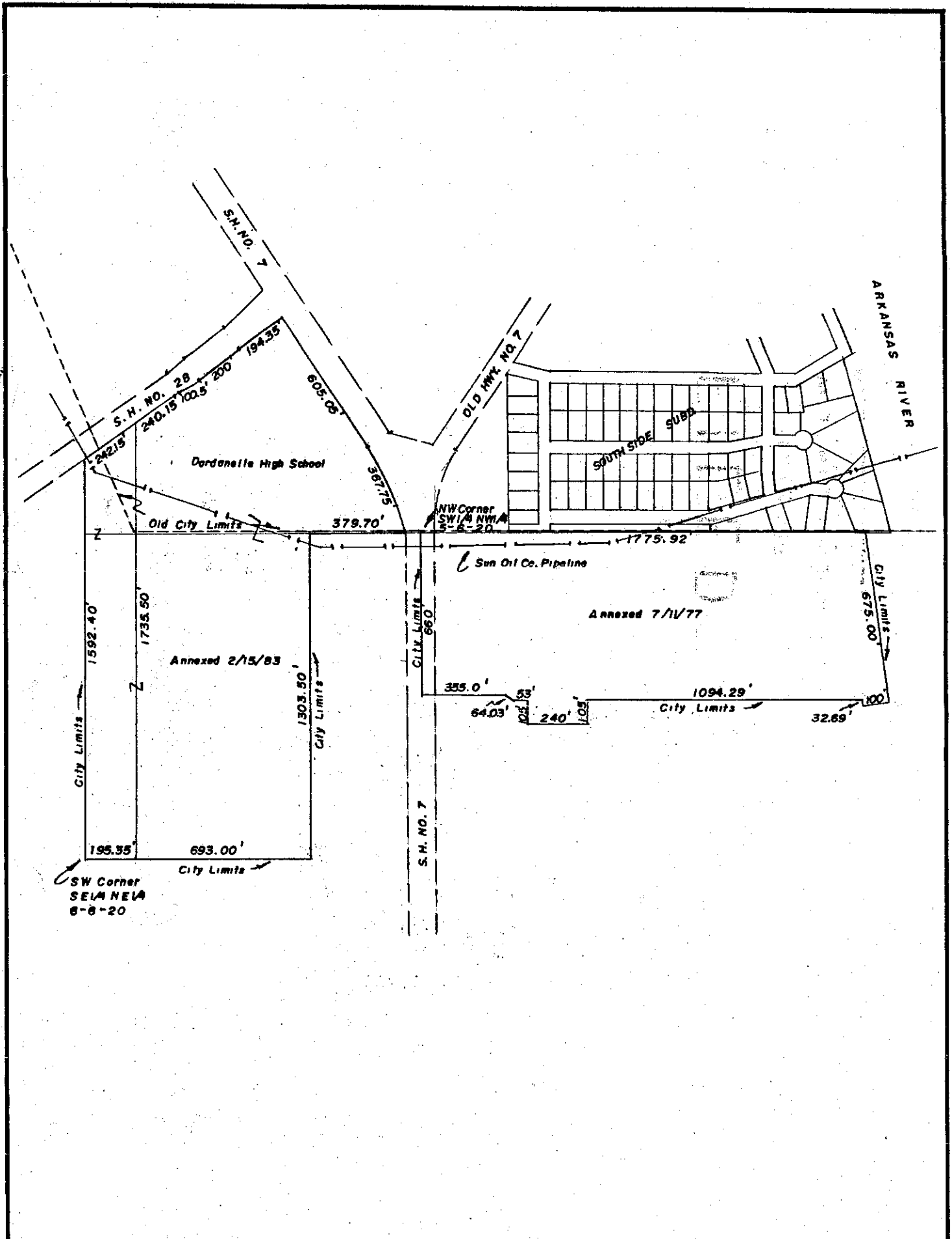

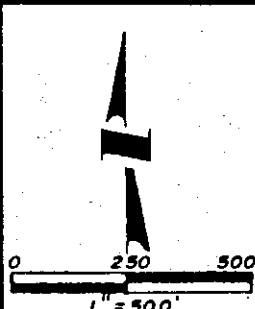

This leads me to believe that we may also have the municipal boundaries wrong for this area, too. But, it may be that what the Census has for the city limits (and the precincts) may actually be more correct. Can you please take a look at the attached map? According to your records, which is a more accurate depiction of your city limits, Census or the state? If neither is correct, then I might need to track down the ordinance(s) that describe the area so we can get it corrected on the state and Census maps.
