## ORDINANCE NO. 2015- O

#### CITY OF ELM SPRINGS, ARKANSAS

ORDINANCE ACCEPTING THE **ANNEXATION** CERTAIN TERRITORY, KNOWN AS THE O'BARR PROPERTY TO THE CITY OF ELM SPRINGS, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF ELM SPRINGS, ASSIGNING SAME TO WARDS AND DESIGNATING THE ZONING FOR THE ANNEXED PROPERTY.

WHEREAS, the property belonging to the O'Barrs is located in Springdale. Arkansas, and the owners wish to develop it. A request for services was made upon the City of Springdale, which responded, through its City Attorney, that Springdale did not intend to provide services to the property and that the owner should proceed to be annexed by the City of Elm Springs, which borders the property; and that said territory be annexed to, and made a part of the City of Elm Springs, Arkansas; and,

WHEREAS, the Planning Commission has recommend acceptance of the property for annexation and the Mayor of Elm Springs has committed to providing the requested services to the O'barr property and has recommended that Elm Springs annex the property.

#### THEREFORE, BE IT ORDAINED:

Section 1. That the following described lands, described in EXHIBIT A to this Ordinance, commonly known as the O'Barr Property, and territory contiguous and adjoining the City of Elm Springs, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Elm Springs.

Section 2. That the territory described in EXHIBIT A shall be annexed to and made a part of Ward 3 of the City of Elm Springs, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 3. ZONING. The territory described in EXHIBIT A shall be zoned \_\_. The City of Elm Springs Zoning Map shall be changed as soon as is practicable to reflect this annexation and these zoning designations.

Dear Mr. Obarr:

I am in receipt of your letter regarding your desire to avail yourself of the provisions of Ark. Code Ann. §14-40-2002, as it pertains to obtaining sewer service to your property located at 5847 W. County Line Road in Springdale. I forwarded your request for services to the Springdale Water & Sewer Commission, who has informed me that they currently have no plans to provide the requested services to your property as requested in your letter.

As such, the City of Springdale is not able to provide you with a commitment to provide the requested services at this time. Accordingly, you are free to pursue your right to de-annex from Springdale and annex into Elm Springs for the purpose of obtaining the services you request.

Please be advised, however, that all of the requirements of Ark. Code Ann. §14-40-2002(b)(3) must be met for the property to be de-annexed from the City of Springdale. In addition, should you wish to rezone the property after it has been annexed into the City of Elm Springs, any such rezoning request would be subject to the requirements of Ark. Code Ann. §14-56-306.
