

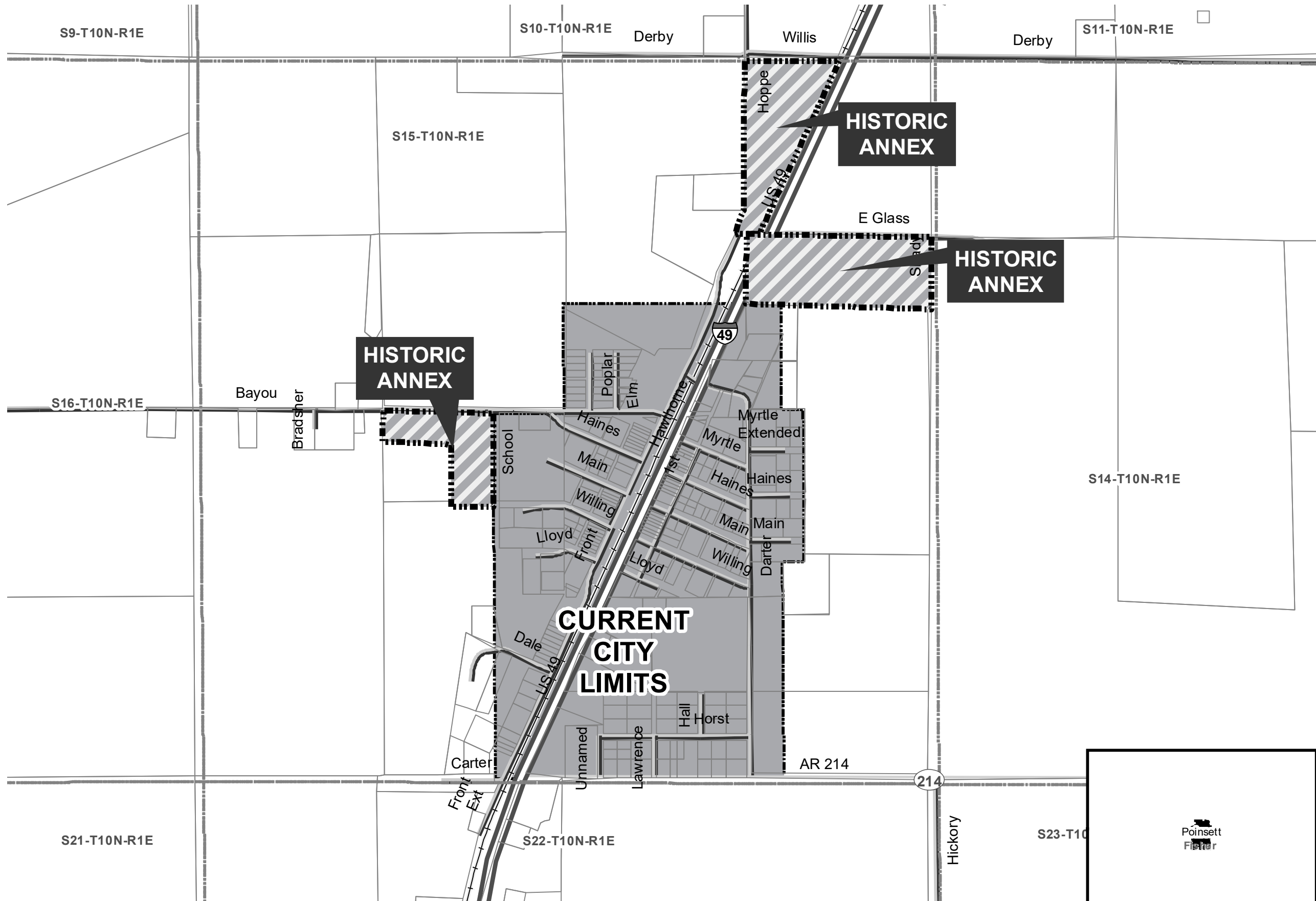

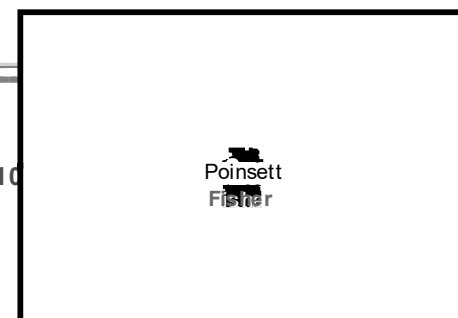
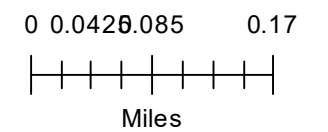
Arkansas Code 14-40-101.

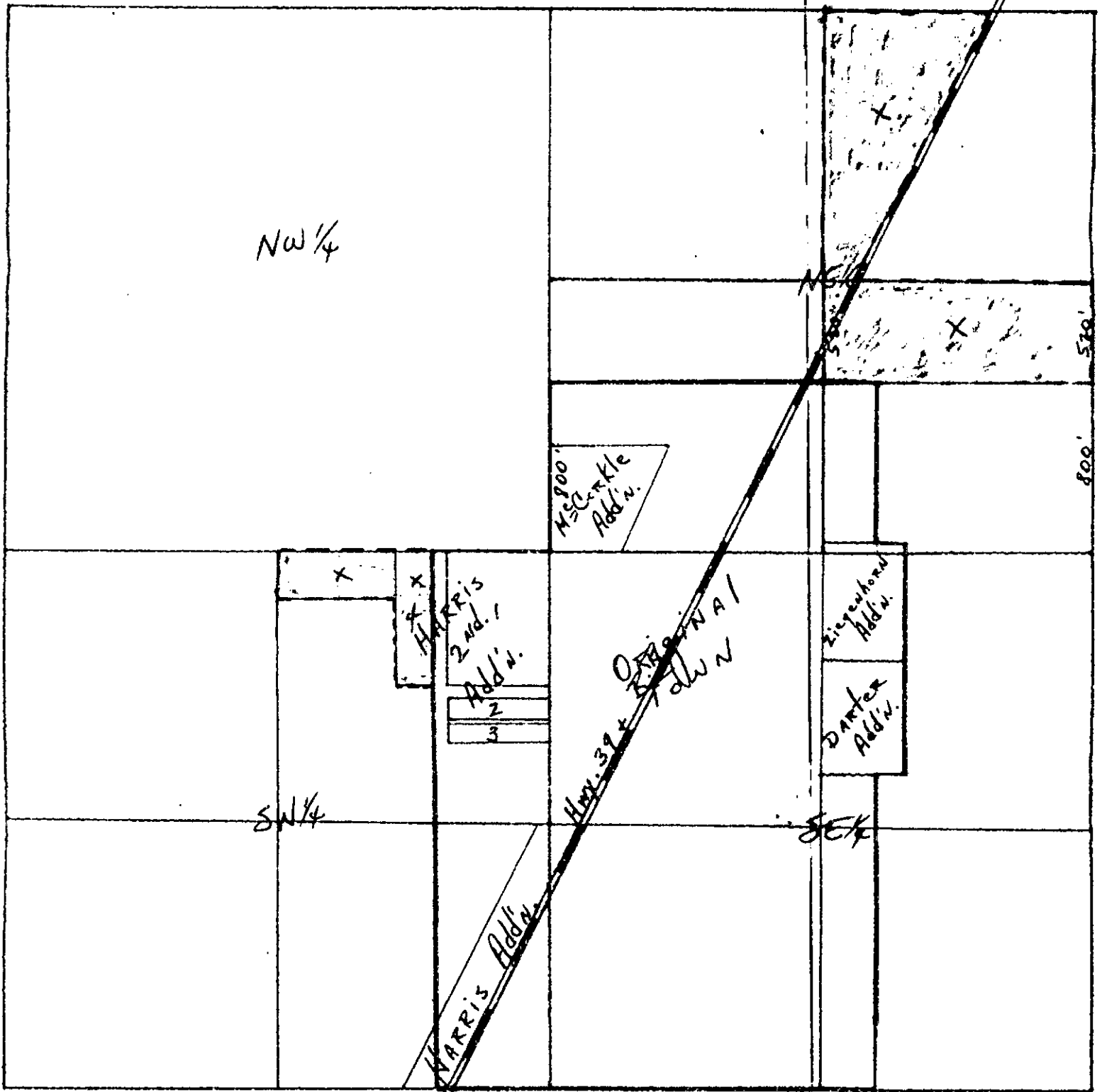

ORDER CONFIRMING ANNEXATION

On this 16th day of December, 1969, comes on to be heard the application of Forrest D. Smith, agent of Petitioners in the above entitled matter, for confirmation of the Order of this Court made and entered on the 16th day of December, 1969, annexing to the Town of Fisher the following described territory, to-wit:

The Northeast Quarter of the Northeast Quarter of Section 15, Township 10 North, Range 1 East, lying West of the Railroad;  
The North 520 Feet of the Southeast Quarter of the Northeast Quarter of Section 15, Township 10 North, Range 1 East;  
All of Block 4 of the Harris Second Addition to the Town of Fisher, Arkansas; and  
Part of the Northeast Quarter of the Southwest Quarter of Section 15, Township 10 North, Range 1 East, described as follows: Begin at the Northwest Corner of the said Northeast Quarter of the Southwest Quarter and run thence South 200 feet; thence East to the West line of Block 4 of the Harris Second Addition to the Town of Fisher, Arkansas; thence North 200 feet; thence West to the point of beginning;

And it appearing to the Court that no notice has been given to said agent of said Petitioners, nor to any of the town authorities, that there has been instituted a proceeding in the Circuit Court to have this annexation prevented, and that in fact no proceeding has been instituted in the Circuit Court although more than thirty days have expired since the entering of said Order of Annexation; and there further appearing to the Court that the Town of Fisher has duly accepted said territory by proper resolution, evidenced by certified copy thereof filed herein, as a part of the incorporated Town of Fisher extending its limits to correspond with those described above.

IT IS, THEREFORE, CONSIDERED, ORDERED AND ADJUDGED by the Court that said Order of Annexation heretofore made annexing

RESOLUTION ACCEPTING ANNEXATION OF TERRITORY

WHEREAS, on the 16th day of December, 1969, the County Court of Poinsett County, Arkansas, entered an Order on a Petition of owners of real property annexing to the corporate area of the Town of Fisher, Poinsett County, Arkansas, the following territory, to-wit:

The Northeast Quarter of the Northeast Quarter of Section 15, Township 10 North, Range 1 East, lying West of the Railroad;  
The North 520 feet of the Southeast Quarter of the Northeast Quarter of Section 15, Township 10 North, Range 1 East;  
All of Block 4 of the Harris Second Addition to the Town of Fisher, Arkansas; and  
Part of the Northeast Quarter of the Southwest Quarter of Section 15, Township 10 North, Range 1 East, described as follows: Begin at the Northwest Corner of the said Northeast Quarter of the Southwest Quarter and run thence South 200 feet; thence East to the West line of Block 4 of the Harris Second Addition to the Town of Fisher, Arkansas; thence North 200 feet; thence West to the point of beginning;

And it appearing that the annexation of said territory is for the best interest of the inhabitants of said territory and the inhabitants of said town and that the same should become a part of the said Town of Fisher.

NOW, THEREFORE, BE IT RESOLVED, That the territory so annexed by the Order of the County Court to the corporate area of the Town of Fisher be and the same is hereby accepted and that same be made a part of said Town and that, hereafter, the inhabitants residing therein shall have and enjoy all rights and privileges of the inhabitants within the original area of said town and be subject to all duties and responsibilities of the inhabitants of the original area of said town.
